The amount being requested \$900,000.00, will cover the next three years of service, \$300,000 per year. Two different quotes have been provided: one quote is for the parts, labor, maintenance, calibrations and on-site repair; the other quote includes the management software cost. Scott Candler currently uses the system to verify the calibration of the water quality monitoring equipment. Hach Co. service technicians are the only people authorized to start-up, repair, calibrate and maintain Hach Co. equipment without voiding warranties. Terms and conditions have been previously approved by the Law Department, in accordance with the agreed upon addendum.

A sole source CPA No. 1042139 was awarded to the vendor, effective December 13, 2016 – December 31, 2018, in the amount of \$300,000 for water monitoring equipment and repair services. The current CPA 1108179 is due to expire on May 31, 2019, the current amount released is \$564,845.88. This was advertised on the GPR for a period of 15 days.
