Phyllis,

Per our conversation and notification, Pratt Recycling luc, will not be renewing Invitation No. 3003295 for an additional term, under the same price, terms and conditions for another year. The value of the commodities that make up Residential Single Stream has fallen dramatically since the Agreement Effective Date of October 14th, 2014.

We are offering the following options for continuation of processing Residential Single Stream delivered to Pratt Recycling facilities subsequent to the expiration on October 31st, 2019.

From October 31, 2019 through December 31st, 2019, Pratt will receive Residential Single Stream that is delivered to Pratt Recycling facilities at \$0.00 charge and \$0.00 rebate.

Effective January 1, 2020, Dekalb County may choose either of the following options:

Option #1

Pratt Recycling will invoice and Dekalb County will pay \$60.00 per ton for every ton of Residential Single Stream delivered to Pratt Recycling facilities.

Option #2

Pratt Recycling will invoice and Dekalb County will pay \$95.00 per ton for every ton of Residential Single Stream delivered to Pratt Recycling facilities. Pratt Recycling will rebate Dekalb County 50% of the composite value of Residential Single Stream material. The composite value will be calculated and adjusted every 3 calendar months.

Both of these options will require at a minimum, a three year Agreement.
