Detailed Description of Requested Changes: We are requesting to extend contract term for another 90 days and add additional funding in the amount of \$1,596,388.76 from the 2018 LMIG account. Due to weather delays and utility conflicts, the Contractor was not able to complete paving of designated roadways. This proposed amendment enables the contractor to continue working on road resurfacing projects and finish the list of roads to complete Phase 1 SPLOST and the 2018 LMIG.

Justification for the Proposed Changes and an Explanation of why the County should not consider a Competitive Bid: Pittman Construction Co. is one of the two contractors that were given a contract in response to ITB No. 18-100921 to resurface roads throughout Area B in Dekaib County. Pittman Construction Co. contract expires November 9, 2019 but with the proposed term extension and funding this gives the County more time to finish maintenance related to our road resurfacing projects.
