Detailed Description of Required Changes: We are requesting for additional funding to the GDOT agreement for SR 212/Browns Mill Rd at CR 594/Salem Rd improvement that is associated with Watershed Management in the amount of \$48,420.00. This will ensure that there are adequate funds on this agreement to enable the contractor to complete the work on our water and sewer installation/adjustments.

No: 0009988. GDOT original quote submitted to DWM dated June 4, 2018 stated the total low bid for this project was \$4,873,402.03 with DWM portion being \$979,590. CMES submitted a change order to GDOT for the additional quantities dated November 26, 2019 in the amount of \$48,420 for the Browns Mill Rd/Salem Rd roundabout project.
