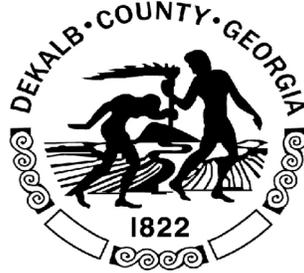

Teresa Hardy, President NAACP DeKalb County Branch #5192, 3011 Rainbow Drive, Suite 180A Decatur, Georgia 30034 - To the Board of Commissioners and CEO Michel Thurmond, we are writing to express our concerns regarding the upcoming elections. We have been in the community educating and providing tools and information for citizens to #GetVoteReady. We must inform you that we are receiving many calls regarding not receiving ballots for the 9/29/20 Congressional special election. This raises a flag for our readiness for 11/3 so we wanted to let you know so that we can address asap. As discussed in the voter experience townhalls, we are expecting more communications, more poll workers, more drop box locations as well as precincts. We have been waiting for the communications to share with voters however the website has not been updated as we had expected. In the town halls, it was mentioned that we were hiring additional help to support the unreadiness that occurred on June 9th. Have we hired the person(s) for all the available jobs? We continue to get calls asking to be poll workers and we refer them to the Voter Registration & Elections department. However people are informing us that they are not receiving any communication regarding the status. Please understand that we are faced with many crises but DeKalb can be the Leader in excelling in the midst of the Pandemia season. We are here to assist and support to make this season successful. Now today is National Voter Registration Day and we usually are set up throughout DeKalb high schools but due to COVID we have adjusted. NAACP Volunteers will be at DeKalb Libraries conducting voter registration drives from 10 am -4pm (see attached). We welcome volunteers and anyone who needs to register to drive through to #GetVoteReady. We appreciate all of you and your dedication to serve DeKalb County citizens and look forward to working together for a successful election

2. Dr. Ed Williams, P.O. Box 361626 Decatur, Georgia 30036 - Good Morning Commissioners. My Name is Ed Williams, I have lived in unincorporated south DeKalb for over twenty years. I am the chair of the group Concerned Citizens for Effective Government. The mission of the commission is to improve quality of life and provide a responsive government through its function as the legislative branch through appropriations and making public policy. This morning I would like to take a moment to ask the commission to look into the franchise fees and the police services agreement between the cities of Tucker and Stonecrest. The amount of Franchise fees lost to the City of Stonecrest is 3 million in 2019 and 3.8 million in 2020. The amount of the City of Tucker Franchise fees lost to Tucker is 1 million in 2019, and 2.3 million in 2020. The BOC has a fundamental responsibility of oversight through its power to adopted ordinances and appropriations. So why does the commission continue to allow the City of Stonecrest and City of Tucker to collect their franchise fees for cable, power, and phone services and yet pay the same property tax for police services as unincorporated DeKalb residents? Currently, unincorporated residents franchise fees go to the county and help to supplement the police services, but the city of Tucker and Stonecrest receive the same police services however they get to collect their franchise fees and use them for other purposes. This arrangement means that Tucker and Stonecrest residents are getting the same police services as unincorporated DeKalb residents at a lower cost. This is not fair and the commission and the CEO should do something to correct this inequity. What does it take to get elected officials to look out for residents in unincorporated DeKalb the same as you all are doing for residents that live in cities? The residents in unincorporated DeKalb County votes should count the same as residents in cities. The commission should stop taking the residents in unincorporated DeKalb for granted. It is a sad day when elected officials are not providing equal services and discriminate against residents in terms of service delivery and costs. As I speak to you today I think of the song "I'll take you there" song by the Staple Singers. I am yearning for a DeKalb County where the commission and CEO take the residents to a place: Where there are smilin' faces, Where Ain't nobody cryin', Where Ain't nobody worried, Where Ain't nobody

Lyin' to the races. Thank You

3. Ryan Brown, 780 Rowland Rd, Stone Mountain, GA 30083 - Commissioners, I think it is great that the county is now able to conduct business by zoom meetings and virtually. It is also great that I can email my comments and not miss work to make public comments. I want to talk about concerns that I have about the process for adopting the Memorial Drive Plan into the county's Comprehensive Plan. According to the Memorial Drive Plan, the "market area" is home to over 90,000 people. The land use changes proposed for adoption will affect A LOT of people. For a plan that touts its public participation, why has it been buried at the end of a 5 hour+ agenda? Additionally, as you may know, I was not allowed to make comments on this item before the Planning Commission on September 1, 2020. After waiting over 8 business days for a response from the planning department, I found out that the legally required policies and procedures for comment on zoning public hearings have not been updated since 2019. I urge you to get these procedures updated and adopted. Following the law and having a transparent process is important and may have avoided issues like I had at the Planning Commission meeting. I've copied all of you on my emails to Andrew Baker on this issue - please read these for more detail. Overall, the Memorial Drive Plan's adoption into "the official policy of the county concerning designated land uses and development types," which is how county law defines the Comprehensive Plan - deserves more public awareness of the land use changes proposed and to not have questions about whether there was appropriate public hearing of this zoning decision. Additionally, deferring the Memorial Drive Plan would put it at the top of the agenda, where it deserves to be, so that the public doesn't have to wait until 10:30/11 pm at night to hear and comment and hope that someone notices a virtual hand raised late at night. You should update your public hearing procedures to be in compliance with Georgia zoning law and defer the Memorial Drive Plan's adoption. Thank you

4. Stephen Binney, (no address) - Good Morning Commissioners, During the Marta update last week we were told that 3 of the old Dekalb routes have been reinstated. Route 125 and one of its destinations, DFACS, is one of those routes. I want to thank those commissioners who led the effort to get this route going again as it was sorely missed by those Dekalb residents and children most in need. With MARTA's sale tax collections remaining stable and their charging of fares again, I believe it is pass time for Dekalb county to demand full bus service restoration. If you are paying full price you should be getting full service. MARTA has been short changing us for decades and it continues today. Your help is needed to get county residents the service they are paying for. In addition, the ATL has recently recommended nine transit projects for possible state funding next year. I don't believe that any of these projects are in Dekalb county. Will the circle ever be unbroken? In 2010 the Special Purpose Grand Jury found many "Red Flags" of LSBE abuse in Dekalb County. We will be reviewing these one by one in the coming months because none of these "red flags" has been addressed or corrected over the last 10 years. Today's "red flag". "Contracts for work for which the LSBE has no previous history, licenses, or equipment". This allows the prime contractor to receive the extra bid points allotted to prime contractors who make use of an LSBE for 20% of the contracted work. This continues today since there are still not enough employees to check the veracity of submitted contracts or registrations. A news story this week suggested that Dekalb County has an employee with a second job that includes helping companies navigate the county's LSBE process. Her knowledge and information could be of great use to correct our LSBE problems, if you would only take the time to talk to her. But you would rather give an additional 260 thousand dollars to a company that has failed to do the job over the last 5 years. Will the circle ever be broken? Dekalb County Watershed has taken credit for the small number of sewage spills over the last few

months. Will they also take responsibility for what happened last Thursday? At least 18 sewer spills were reported in DeKalb County, as the remnants of Hurricane Sally dumped several inches of rain in our county. Initial spill reports did not provide information about the potential volume, but earlier this year amounts were in the millions of gallons during a similar rainy period. Many of the spills were at regular trouble spots like the Meadow Creek Path near Lithonia that saw two multi-million gallon spills earlier this year. Yet the County still seems more involved with increasing capacity for future business than in correcting the mistakes of the past and keeping our rivers and streams safe for our children. Will this circle remain unbroken also? Thank you

5. Robert Hanna, ISA Sports Owner 5639 Memorial Drive Stone Mountain, Ga 30083 - Greetings Committee Members, my name is Robert Hanna and I am a co-owner of the International Sports Arena located at 5639 Memorial Drive in Stone Mountain Ga. The International Sports Arena (www.ISA-Sports.net) is a 25,000 square foot sporting events and youth athlete development center serving the diverse families in Stone Mountain, Decatur, Clarkston, and other cities in DeKalb County. We offer a place for the youth to get off the streets and play, train, compete, and recover from sport competition. We currently serve over 2,000 youth athletes with our programs and events annually and project that number to more than double over the next 12 months. We are excited to be located on Memorial Drive as the area is underserved with businesses that offer our families in our community opportunities to come together and celebrate youth development and achievement. We see value in bringing our citizens opportunities to "Live, Work, and Play" right here on Memorial Drive. Daily we see more and more residents coming into our facility excited about how our business and others have committed to making memorial drive their home and seeing our commitment to helping revitalize the community NOW! Our business and investment on Memorial Drive is to both current and future residents and the Memorial Drive revitalization plan is spot on with our vision... it is both timely and critical for stimulating local jobs for residents and business tax base to improve community services for underserved residents who live on the corridor.

Our hope at ISA Sports is that all residents and businesses will take immediate action and support the immediate passing of the Memorial Drive Revitalization Corridor Plan. We can't wait... let's put on our hard hats and kick start working together to revitalize the Memorial Drive Corridor today!

6. Martha Gross, 2855 Briarcliff Road 30329 - We are now in an emergency situation in this part of DeKalb – an emergency that will directly any residents that use North Druid Hills for access to and from I -85, Buckhead, GA 400, Downtown or Midtown. The emergency is that we currently have \$2 Billion in new development entitled and under construction at Children's Health Care and Emory's Executive Park campuses. Those campuses will consist largely of hospitals and high-density medical office space, without any significant investment in transportation infrastructure other than potential upgrades to the actual interchange and CHOA from the interchange. In addition to those already entitled developments, there are two new major developments planned for the newly annexed area from Briarcliff to Mt Mariah Road – potentially another Million Square feet of commercial space generated more traffic. North Druid Hills already operates with a fail rating – even before the addition of millions of square feet of new construction – and yet DeKalb County is doing nothing to prepare for this crippling new density. On the last Comprehensive Plan update, we begged for a new and customized Small Area Plan that would reflect the new reality of Children's and Executive Park redevelopments and were promised just that by Planning. They did nothing about that promise and we are all going to pay the consequences, especially North Druid Hills. I am here to beg you to Invest in a third-party professional planner to put a small area plan in place for North Druid Hills and Briarcliff Roads and determine

what can be done to improve traffic mobility. I suspect it will require installation of a median at least in the commercial areas and perhaps an additional lane each direction. We might need to create a CID or some means of financing this, but we need to plan for that now. The old Comp Plan does not work for this area. The current character area is neighborhood center which is defined as serving the needs of local residents and encourage walking. Our Planning Department decided on their own, without any public input, that it was appropriate to permit a 4-story self-storage warehouse in this Character area. They also argued strongly that a Racetrac and a Wendy's could be defined as a mixed-use project and were consistent with a character area designed to encourage walking. This is NOT our idea of either mixed-use development or encouraging walkability. That is why we beg you to hire a third party planner to do a small area plan for our area NOW before it is too late

7. Ammanuel Dawit, 824 Hearthstone Drive, Stone Mountain, GA - My name is Ammanuel Dawit and I am a teenager who lives at 824 Hearthstone Drive, Stone Mountain, GA. off Memorial drive. My mom took me to several meetings held regarding the Memorial Drive Revitalization Project. I was excited to give my opinion on what I wanted to see on Memorial drive. Memorial drive really needs an update. I can't wait to see things change and be better so we can enjoy our community even more. I love living in this diverse community unlike any other place in Atlanta and this project will help towards this vision of mine and many others.
