This request is to approve the purchase of a 6-year contract for annual capture of Pictometry's high resolution oblique image. EagleView Technologies Inc. formerly Pictometry International Corporation has been supplying the County with its oblique imagery on an annual basis since 2003, with over 500 users and an established interface with the County's CAD-911 system.

EagleView's oblique imagery is in proprietary format and cannot be used with any other provider's software.

The County's spend to date with the Company is \$1,948,170.34.

I recommend approval of this sole source provider, because changing vendors will limit the County's ability to view current and archived oblique imagery. Pictometry's software license would still be needed to access previous years of imagery.

Answer to question #1:

Pictometry provides the County a proven product that suits our oblique imagery needs. Pictometry International Corporation has been supplying DeKalb County with its oblique imagery on an annual basis since 2003. All of the image data is being stored in the cloud hosted by Pictometry, allowing us access to any year via web browser through a desktop or mobile device. We also have the option to install the software on a desktop or server base if the cloud is no longer a viable option. We currently have about 500 users of Pictometry with the numbers increasing. The advantages the county would get by continuing with Pictometry are:

- Long-term initiative Option=Cost Savings
- Access to surrounding county imagery (Fulton, Cobb, Gwinnett)
- Disaster Response Program (no charge)
- Already established interfaces and plug-in with the DeKalb's CAMA (Tyler) system.
- Partner and integrates with our Tyler Public GIS website.
- Established interface with DeKalb's CAD-911 system (TriTech).
- Staff and users already trained and familiar with the use of the software as well as In-field Technical Manager and training.




