### **PURPOSE:**

To resolve Edith Holley's property damage claim, 3774 Chateauguay Drive, Decatur, Georgia 30034.

### NEED/IMPACT:

To resolve a property damage claim and avoid litigation risks.

#### FISCAL IMPACT:

\$110,548 from watershed funds.

#### RECOMMENDATION:

Defer this item to the December 15, 2020 Board of Commissioners meeting for a vote to approve payment of the total sum of \$110,548 to Edith Holley to resolve her property damage claim arising from a December 2, 2019 water main break, in return for and conditioned on Ms. Holley's execution of an appropriate release and waiver of claims.

Proposed resolution of watershed claim from Edith Holley

The Law Department anticipates that on December 8, 2020, the proposed \$110,548.00 resolution of citizen Edith Holley's property damage claim from a December 2019 water main break may be placed on the BOC's agenda for proposed approval, then deferred for a vote on December 15, 2020, without discussion in an executive session.

The Law Department often brings proposed settlements to the Board of Commissioners in executive session. However, under the Open Meetings Act, an executive (closed) session can be held to discuss litigation or threatened litigation only if there is an actual lawsuit or a direct threat of a lawsuit made in writing or through an attorney. The proposed resolution of Ms. Holley's claim was negotiated between Watershed Management representative Brian Robinson and Ms. Holley, without any threat of litigation being made. Ms. Holley sent the Watershed Management Department correspondence regarding her property damage claim, but none of her correspondence directly threatened litigation.

Because Ms. Holley has not threatened to sue, her claim and the proposed settlement are not appropriate for discussion in executive session. However, the proposed resolution does require approval of the governing authority. We therefore request that you review this memo and

individually contact me, the County Attorney, or Zach Williams with any questions you have about this item, before it comes before you for proposed approval.

Ms. Holley's claim arises from a water main break that caused flooding at her residence at 3774 Chateauguay Drive, Decatur, Georgia, 30034 (in Districts 3 and 7) on December 2, 2019. She claims there is still-unrepaired damage including no flooring on the main level of the home, a damaged and unusable laundry room, mold and mildew, water in utility room, and clogged drains. Watershed Management employee Brian Robinson asked Ms. Holley for estimates of the costs to repair her home, and two estimates were provided. Ms. Holley advised in an email that she would accept the proposed settlement amount of \$110,548.00.

Documentation of the estimates/claim is attached for your information, along with a draft agenda item. If you have questions about this proposed resolution, please contact Zach Williams, the County Attorney, or me. As noted above, we anticipate this item may be added to the agenda for proposed approval on December 8, 2020 and deferred for a vote on December 15, 2020, but will not be discussed in executive session.

#### **DESCRIPTION OF DAMAGE:**

An inspection was not completed as we were requested to compare two estimates provided by the claimant, Edith Holley.

Insured: DeKalb County File No.: Unknown

We received an estimate from Capital Improvement Group for the amount of \$99,209 and a second estimate from ARC Remodeling Experts for the amount of \$104,475. We compared both estimates and we confirmed both estimates almost have the same scope of work for the repairs to the property. The only difference we found on the scope of work between both estimates was the additional supervision hours for the electrical work for the amount of \$4,509.50 under the Capital Improvement Group estimate and there was no additional supervision hours for the electrical work under the ARC Remodeling Experts estimate. Below you will find a breakdown of the dollar amount comparing both estimates for your review.
