- Dear DeKalb Commissioners, we would like to thank you for allocating time out of your schedule to address and resolve the resurfacing and paving issues within River Vista Estates, that were not properly constructed by the original developer in 2005. As a River Vista Estates Homeowner and tax payer, I am urging the Commissioners to unanimously approve the Public Works - Roads & Drainage Item Number 2020-1616, which would finally fix the improperly developed roads in our community. River Vista Estates is a well-manicured established community of single family homes located on River Road in Ellenwood, DeKalb County, Georgia. Currently, River Vista Estates has 281 lots that currently has 253 single family homes featuring expansive 3, 4 and 5 bedroom homes that are priced from \$350 - \$500 thousand dollars. Additionally, 20 new homes are in various stages of construction. River Vista Estates Homeowners are proud and avid voters, who paid approximately \$1,145,760 in property taxes in 2020, thereby driving the DeKalb County Tax Commission to establish a community valuation of over \$90 Million. Our community streets are plagued with numerous pot holes, huge depressions, wash outs, unevenly paved streets and other problems, which routinely cause damage to our vchicles and adversely affects our property values. We recognize the Commissioners' efforts to address and resolve constituent issues and hope you will work to resolve our dilemma. We look forward to your unanimous approval.

2. Steve Goodsell, 3715 Northside Parkway, 100 North Creek, Suite 130 Atlanta, GA 30327 - I own a number of lots in River Vista. The condition of the road in front of the lots is unacceptable. There is no excuse

for a neighborhood to not have safe and passable streets. None of us in the neighborhood are responsible for what is happening with the roads – that is on the county. It is the county's responsibility to fix it. Please take up that responsibility and deal with it. Thank you for your attention to this matter

3. Ellie Thaxton, 775 Northern Ave, Clarkston GA - Dear CEO Mike Thurmond and Dekalb Board of Commissioners, My name is Ellie Thaxton, and I live at 775 Northern Ave, Clarkston GA (unincorporated Dekalb). I have been working alongside several nonprofits helping tenants to apply for rent assistance with the Dekalb Citizens Assistance Program. Though the local nonprofits have been faithful to administer the money Dekalb allocated to them for rent assistance, they are having to turn away hundreds of people on the brink of homelessness because of lack of funding. In fact, as of the end of November, 6100 evictions are still pending in Dekalb that were filed between March to November. The majority of these eviction cases involve Black and immigrant tenants, most commonly single mothers of small children. Though federal rent relief is coming, this funding will be too little and too late for most of the thousands of families still under eviction. Dekalb has done many great things to try to fight COVID and build back the economy, but by not passing adequate funding to stop evictions, we're afraid you are defeating your efforts in many ways. It is possible that thousands of folks will become unsheltered when the CDC moratorium expires at the end of the month. These citizens will lose their jobs, their children will stop schooling, many children will go into foster care, and citizens will die from exposure to COVID, or the cold. The increased costs to the county on policing, social services, rehousing, and more, will be greater than the cost of allocating rent assistance now. While Gwinnett has spent over \$13 million in rent assistance, according to a recent post by Commissioner Bradshaw, Dekalb has allocated only around \$5 million. CEO Mike Thurmond stated that the county still has CARES Act money that has not been spent. We nonprofits are coming to urge the CEO's office to allocate \$12 million of the remaining CARES Act funding towards rent assistance now (an average of \$2000 for each of the 6000+ tenants facing eviction). Please, hear us nonprofit leaders and community advocates who stand ready to help these tenants if provided the funding. We must take an aggressive approach and work together to prevent evictions as in the examples of Gwinnett County and the City of Atlanta. We will be following up by email. We look forward to working with you

4. Stephen Binney, (no address) - Happy New Year Commissioners, I want to welcome Mr Patrick and Mr. Terry to the Dekalb County Commission. I look forward to your fresh ideas to make our County a better place to live. Dekalb County governance sometimes has a way of assimilating its commissioners into its system of secrecy and old habits. I hope you will work towards evolving our current system into a more open and efficient type of government. On today's agenda is an item transferring over 320 thousand dollars from 2001 Park Bond funds to the new Community and Senior Center to be built off Elam Rd. I ask all Commissioners along with the legal, parks, and accounting departments to take a closer look at this transfer of funds. First off, does a Community and Senior Center meet the legal definition of a park. More important however are the rules and guidelines attached to the 2001 Park Bond. On March 20, 2001, DeKalb County voters approved the issuance of \$125 million in general obligation park bonds for the following types of projects in unincorporated DeKalb County: land for additional parks and natural areas, preservation of green space, protection of clean water, improvement of existing parks, and development of new park facilities. Use of bond funds, as specified in the 2001 bond referendum are to be used in the following ways. At least 70% dedicated to land acquisition for parks and green space. No more than 30% dedicated to park improvements and developing new facilities Since Dekalb County already owns the land on Elam Rd this money would not qualify under land acquisition costs. There was one phase of improvements and developing new facilities approved in September 2001 with a phase two to be following shortly thereafter. I believe all of the improvement money has already been spent and the county needs to confirm if it has been or not. The fact that Dekalb County passed another Park Bond in 2005 with an allocation of 70% towards improvement and developing tends to back up that all the improvement funds from 2001 had already been allocated and spent. I support the new Senior Center but I want our County funds to be spent legally and in the way promised to Dekalb County voters, even if it was 20 years ago. Also on today's agenda, the defaulting of 38 developers on their infrastructure commitments will end up costing Dekalb County over 2 million dollars in the future. If developers can't keep the promises they make to Dekalb County, they should not be allowed to develop in the County. Thank you for your time and consideration
