- John Winterhawk, 1210 Carson Graves Rd. Watkinsville, GA 30677 My name is John Winterhawk. I want to speak to you this morning about the cannon on the Decatur Square. I want people to know that I am half Muscogee Indian, about a quarter Scotch-Irish, and a quarter Cherokee. My mission is to have equal treatment among people. This is such a big task that it seems impossible to do but my heart yearns for it so much that I am trying to do anything I can to have it come about. When I see one race or the other trying to be the supreme being, I ask what is supremacy? In my mind, it is trying to take the place of Creator. The reason slavery happened in this country is because there was a crack in the wall and supremacy slipped through. In our hearts, we have to be equal to each other or we will never get to the place we want to be. The Muscogee Nation raised our children here on this land which is a gift from Creator. It is not to be taken lightly. This ground supported us in raising crops to feed our families and to hold the green corn ceremony which is a celebration of the first fire that Creator gifted us. Creator drew us together and said I want man to carry my fire and carry my heart and carry my spirit for one another. He said I give you this fire for one common reason. I have placed this fire in the hearts of all people to come and stand at the fire and have peace together. Let there be no more war. No more fighting. No more arguing. No petty beliefs. Only honor, love, respect, and kindness will be shared. Until that moment happens there will be no peace. We have these weapons we're showing that have been historically used in battle. Do we still need to do this in modern times? To show how one group lorded over another? I don't see what that gets us but more lording over each other. It's time to bring that to a stop and ask ourselves why we needed to do that. It's not fair to lord over each other because we are just humans, wonderful humans. There is a place in all our hearts where we have glorious wonder and when we touch that in each other, we glow in the dark. Our teachings have been erased. They have been replaced by supremacy teachings and weapons of war for people to look at every day. Do we want to tell stories of war and being supreme and taking over people's lands, destroying their way of life, and removing them to another place they don't know? I believe we have lost the ability to ask the question, "Have I turned around right? Am I walking in the light?" You can judge yourself. Which do I want? To walk in the dark or the light? Respect, honor, and wisdom is what we are trying to gain in our journey back home. We must stop and speak to our hearts. Please remove this weapon of war. Thank you for your time
- 2. Mary Hinkel, 1718 Mason Mill Rd. NE Atlanta, GA 30329 Even though the Board's Consent Agenda withdraws Item 2020-1415 asking the County's State Legislative Delegation to pass a resolution allowing the Board of Commissioners to make appointments after the CEO delays doing so for 120 days, DeKalb Citizens Advocacy Council would like to alert the Board of Commissioners to the CEO's failure to appoint a Chair for the Charter Review Commission after his appointee, Judge Gregory Adams, resigned in March 2020. We believe the CEO's inaction represents a clear violation of a promise to the citizens of the county. Recognizing that the pandemic has required the CEO's attention, members of the Charter Review Commission have been respectful of his unilateral suspension of the Commission's work after only one informational meeting. Nevertheless, it has now been a year with little communication from the CEO. Other County boards are working, and sufficient time has passed that the Commission should get to work, but no Chair has been appointed. The Commission is being held hostage by the CEO's lack of action. Several members of the Charter Review Commission have called upon the CEO to appoint a Chair so the Commission can officially begin its work. In the meantime, a draft of bylaws for the Commission, begun last February, has been created and Commission members are participating in unofficial educational sessions to begin to review the Organizational Act. The CEO's lack of action in this matter has been disrespectful to the citizens of DeKalb County, who have been calling for a Charter Review Commission for nearly a decade, and disrespectful to the

appointed members and the appointing authorities. The CEO'S inaction in this matter speaks to why the Commission should review the County's board appointment process and take specific action to engage DeKalb's citizens in a more organized and transparent process

- 3. Martha Gross, North Druid Hills Residents Association Picture a high-profile corner lot operated as a junk yard storing a couple hundred abandoned vehicles. Imagine an old gas station without a tenant for the past 20 years, broken windows, huge weeks growing in the asphalt, and a roof that has caved in. Or an old nightclub that had been shut down as a public safety hazard by the Fire Marshall now trash-filled and covered in graffiti. What goes through your mind? Most people assume there is something seriously wrong with the area and assume it is undesirable and a risky investment. DeKalb allows those conditions to exist on commercial properties for years, even decades! No matter how many complaints residents raise, the situations persist. Many of these owners allow these properties to attract rodents, drugs and other dangers to nearby residents. After years of serious neglect, they sell the sites for 10 times appraised value for tax purposes and the buyer takes it through rezoning, telling the residents they should be glad he is ridding them of that eyesore. There is an easy solution to this problem. Pass an ordinance that stipulates that a property which has received a code violation that is not corrected within 45 days, must wait one year before going through rezoning. The clock would be reset for any future code violations. Our county would look better and residents would not need to apologize to guests for the appearance of commercial sites near our homes
- 4. Debra Vidali, PhD, 1557 Dickey Drive Atlanta, GA 30322 To the DeKalb County Board of Commissioners. I am writing to urge you to remove the 1836 "Indian War" cannon that sits just outside the old DeKalb County courthouse. The cannon is a symbol and a weapon of genocide. For as long as it continues to remain on our square, the cannon stands as a symbol of white supremacy. The cannon sends a violent message of harm and exclusion to the Native American residents of DeKalb County. It communicates a violent message to all Indigenous and non-Indigenous people who live, work, and visit here. The cannon that sits on our square was part of the 1836 forced removal of Muscogee Creek people from Alabama to Oklahoma. History professor Claudio Saunt at UGA has called this a "mass deportation." We know that the aggressive removal of Native Americans in this region was a precondition for the expansion of the plantation economy, and the increased enslavement of Africans. By removing the cannon from the square, my hope is that DeKalb County can begin to more accurately represent and better reckon with these historical atrocities and their enduring consequences. In so doing, we can pursue a path of greater social justice and ethical alignment. My hope also is that DeKalb County can begin to (1) develop positive relations with the Muscogee Creek nations and peoples in Georgia, Alabama, and Oklahoma, and (2) commit to reparative actions that recognize Muscogee and other Indigenous peoples who are living and working in our county. Removing the cannon is a first step towards healing. Thank you for everything you do for our county, and thank you for considering these remarks
- 5. Dr. Sara Patenaude, 2803 Oakland Terrace Decatur, GA 30032 Dear Commissioners, we write as an assembled group of historians who live or work in DeKalb County, study the American South and Indigenous History, or have expertise in the presentation of history to the public, to voice our support for the removal of the 1836 "Indian War" cannon from Decatur Square. The forced removal of the Muscogee (Creek) Nation was one of the darkest chapters in the long history of white supremacy and settler colonialism that imbues every aspect of American history. In Georgia, state and local governments, often acting through militias such as the one formed in DeKalb County, willfully stripped sovereign indigenous people of rights that were guaranteed

them by legally signed treaties and decisions by the U.S. Supreme Court. In violation of these rights, native peoples were forcibly dispossessed of their ancestral homelands, while the Georgia legislature seized the ground from under their feet to offer in lotteries for white Georgians. These shameful actions took place across Georgia, including on the very land on which the cannon in question now sits. By 1836, the Muscogee (Creek) Nation had been largely displaced from Georgia. Yet in that year, the cannon that now resides at Decatur Square was dragged from Decatur to the Georgia/Alabama border for use against Muscogee people attempting to protect the last few acres of land they controlled in Alabama. Following their failed engagement with Muscogee fighters, the DeKalb Cavalry returned home with the cannon, which then became a popular marker of celebration for white locals, fired off at weddings and the Fourth of July. In 1906, the United Daughters of the Confederacy mounted the cannon onto a stone, creating the monument now sitting in front of the historic DeKalb County Courthouse. Monuments are not simple representations of history, nor is this cannon a historic artifact devoid of meaning. This is a symbol of oppression sitting in the heart of our community, celebrating the ethnic cleansing of a sovereign people to allow white people to take control of their land. It is a piece of propaganda meant to support a version of history in which white people led the nation towards a "more civilized" future, purposely denigrating the value of those who already inhabited and cared for this land. That the United Daughters of the Confederacy were involved in such propaganda is not unusual, as they led similar campaigns across DeKalb County and elsewhere to support their white supremacist agenda. Allowing this monument to sit in the heart of our community continues to show support for white supremacy, reveling in the harms at the very core of our history. It is not representative of the diverse community we have in DeKalb County, and should be removed. Signed,

6. Paul McLennan, 851 Alberson Ct. Decatur, GA 30033 - To the DeKalb County Board of Commissioners, the Beacon Hill Black Alliance for Human Rights urges you this morning to finish the job you started on the eve of Juneteenth last year when the monument to white supremacy in Decatur Square came down. On this Martin Luther King Day, Beacon Hill's youth committee and the Black Student Union at Decatur High School were recognized by you for their role in making that historic moment possible. At your last meeting, you voted to recognize John Lewis with a statue in the place where that monument once stood. You cannot go forward with

that plan while still allowing another memorial to white supremacy to remain just a few feet away. What we call the genocide cannon was placed there in 1906 two years before the confederate monument by the same racist organization - the United Daughters of the Confederacy. This war relic honors the 1836 "Indian War" that was a part of violent removal process of the Myskoke (Muscogee/"Creek") Nation from the state of Georgia. As a Black-led organization, we are very clear that the first objective of settler colonialism was the removal of the Indigenous people from their land. The second was to bring enslaved Africans to work that land so that a plantation economy could flourish and provide the wealth that built this country. Particularly in light of the rise of white violence that we recently witnessed, we must clear our public spaces of any memorial to hate and terror. Last May in response to racist incidents in the city of Decatur targeting our Black youth, in particular, Beacon Hill Black Alliance for Human Rights co-chair Mawuli Davis challenged our community to "invest in anti-racist, anti-white supremacist work...to root it out." We see removal of this object as part of our task. The Beacon Hill Black Alliance for Human Rights is inspired by the young people who have taken on the cause of removing this cannon. They took their concerns to the Decatur City Commission which passed a resolution on December 21st to remove it. Follow the lead of these courageous youth and use your authority to remove it now. Koan Roy-Meighoo, Sophia Norton, Bethani Thomas, Erin Gaul, Daxton Pettus, Genesis Reddicks, Julian Fortuna, 310 N McDonough St. Decatur, GA, 30030 - To the Board of Commissioners of DeKalb County. As students of Decatur High School, we are writing to demand that the County Commission take action to remove the cannon erected by the Daughters of the Confederacy that lies in Decatur Square. Memorializing the genocide of Indigeneous peoples in Georgia during the "Indian Wars of 1836", this symbol of white supremacy stands in direct contradiction to our county's ideals and mission. The students of Beacon Hill were recently commemorated by CEO Thurmond for removing another artifact of white supremacy, the Lost Cause Monument that stood a mere 20 feet away from the cannon. Furthermore, as the John Lewis memorial is going to be placed where the Lost Cause Monument once stood, the county contradicts itself and dishonors Congressman Lewis's legacy by keeping a symbol of white supremacy in Decatur. By allowing this cannon to stand in Decatur, Dekalb County is choosing to remain ignorant of the widespread negative effects of colonialism which are apparent in our climate crisis, our education system, and our very notions of beauty, art, and history. By allowing this cannon to stand in Decatur, Dekalb County is promoting violence against already-marginalized groups. By allowing this cannon to stand in Decatur, Dekalb County is complicit in the perpetuation of white supremacy. We call upon the county, as the next generation of leaders in our community, to take action and remove this cannon
- 8. Karen Ship (no address) To the Board of Commissioners of DeKalb County. As Christian clergy and staff who serve a variety of communities in the Decatur area, we are writing to insist that the cannon commemorating the "Indian Wars of 1836" be removed from Decatur Square, as the city has recommended in a resolution passed in December 2020. Placed in the Square in 1906 by the United Daughters of the Confederacy, the cannon memorializes the malicious, violent removal of the Mvskoke (Muscogee/"Creek") Nation from their ancestral lands in Georgia, including what is now Decatur. The cannon remains on the square as a symbol that glorifies, not only war, but also white Eurocentric Christian nationalism. With roots that go back as far as the Doctrine of Discovery, Christian nationalism emboldened European settlers to commit genocide against Indigenous peoples who had lived for centuries, if not millennia, on this continent, clearing the land to make way for a plantation economy made possible only by the enslavement of Africans and other

people of color. Given John Lewis' unwavering support for justice for Indigenous peoples, it would be the height of irony for a statue celebrating his life and work to be erected just feet away from a cannon used in the effort to disinherit the Mvskoke Nation. This artifact does not belong in a public space that purports to be open and inclusive to all people. We strongly insist on its removal.

9. Dr. Ed Williams, P.O. Box 361626 Decatur, GA 30036 - Good Morning Commissioners

My Name is Ed Williams, I have lived in unincorporated south DeKalb for over twenty years. I am the chair of the group Concerned Citizens for Effective Government. Today is a special election day to fill the House District Seat vacated by Representative Pam Stephenson. I encourage all registered voters in house district 90 to vote in South DeKalb. The commission is called to serve and there are residents who need your help. I have met one such person, whose name is Ms. Turner. She is a spirit of caring and love. She lost a loved one named Secoriea Turner. Ms. Turner a fellow resident lives near the corner of Snapfinger Wood and Wesley Chapel where she has erected a public memorial of several young people who have been killed at hands of guns. The DeKalb County governing authority should help to provide a permanent visible location to memorialize the epidemic going on in our communities where young people are dying too young at the hands of guns As in the song Lean on Me song by Bill Withers, Ms. Turner needs a hand as she grieves for the loss of her loved one and those other young people. She weeps for someone to care. "We all need somebody to lean on I just might have a problem that you'll understand We all need somebody to lean on Lean on me, when you're not strong And I'll be your friend I'll help you carry on For it won't be long 'Til I'm gonna need

Somebody to lean on...You just call on me brother, when you need a hand Michael Jackson also sang about the same thing in his songs We are Not alone, We Are the World, and They Don't Care About Us. All I wanna say is that they don't really care about us Tell me what has become of my rights Am I invisible 'cause you ignore me? ... I'm tired of bein' the victim of shame .. You know I really do hate to say it The government don't wanna see The county commission should make its mission true its words that are posted on the walls of the Maloof auditorium and the county website. There should be a public wall of the faces of tears for those who have died at the hands of guns. As the BOC mission states that it "is committed to excellence in public service as a way for the people to participate in a responsive government". For several months Ms. Turner has brought attention to this problem, she has set up a memorial made out of concrete road blocks, lumber, and pictures of the slain children on vinyl. We have come to know this to well, as a silent killer that no one seems to want to talk about or speak about. This Black on Black crime has to be addressed and Ms. Turner is trying in her own way to stand up and say no more killing. What manner of person would not care, that our children are killing each other and will not lend a hand to help their fellow citizen. The words in the song when you are not strong, I will be there I am here to say Ms. Turner keep doing what you are doing. There are people in the community who do care and are watching you. You are not alone. I ask this commission and the CEO to take a lead and to make a difference, to take the road less travel and give this woman a hand

- 10. Natsu Taylor Saito, 2198 Venetian Dr. SW Atlanta, GA 30311 To the DeKalb County Board of Commissioners. I write to urge you to remove the cannon that sits just outside the DeKalb County Courthouse and commemorates the "Indian War of 1836." This monument characterizes the forced removal of members of the Muskogee Creek Nation from their homelands, and their subsequent slaughter, as a "war" that, presumably, "we" won. As such, it glorifies and thereby perpetuates a history of genocide. It also sends a resounding message to the tens of thousands of American Indians who live in Georgia today, a message that says, "you no longer exist," or "you do not belong here." A message to Indian children that their histories, cultures, and identities have no place in DeKalb County. I appreciate your recognition of the need to remove symbols celebrating the Confederacy and hope that you will recognize--as did the Daughters of the Confederacy--that the elimination of Indigenous peoples and the enslavement of African peoples are inextricably linked "causes." If, as a society, we wish to proceed in unity we will have to be honest about our histories. Removing this cannon--a symbol of violence, conquest, and racialized hatred--would be a good step in that direction. Thank you for your consideration of this very important issue
- 11. Stephen Binney, (no address) Good morning Commissioners, Mr. Patrick, you did something I have never heard before at a Zoning meeting and I want to thank you very much for doing it. You publicly stated which developers or individuals had contributed to your campaign before you voted on their rezoning requests when applicable. I hope that the other Commissioners will follow your example in future meetings. Your honesty, openness, and transparency is what the public should expect from it's Dekalb County elected officials. On the other hand Mr Bradshaw your performance was less than stellar and more in line with business as usual in Dekalb County. After the presentation on the Erskine road proposed development Commissioner Terry was about to make a motion when you interrupted him. You told us that of the many people you had spoken with, absolutely no one had said they were in favor of this development. There were traffic concerns, sewage concerns but especially loss of property value concerns. You said there was no need to defer this item for further negotiation and made a motion for a denial of the request. What you did not tell us was that you live on property bordering this proposed development and had a direct financial interest in the final decision. During the

November Zoning Meeting you abstained because of the possible appearance of conflict but in January you led the effort to deny the application. What changed? Why didn't you withdraw from the process and abstain from voting like last time? That would not only have been the morally right thing to do but was also the legally required thing to do. How can the citizens of Dekalb County trust you Chairman Bradshaw when you openly abuse your power. I watched the OPS meeting last Tuesday and Mr. Terry you are not ready for prime time. You could not do anything without asking for Mr Bradshaw's OK. Your OPS committee is recommending withdrawing 1413,1414, and 1415 today. Do you know any of the history behind these legislative requests? Negotiations on a transparent and efficient procurement system began before February 5th, 2019. That was over 2 years ago. Mr Thurmond promised to put the Charter Review Commission together over 2 years ago. He delayed making his appointments to the board and they finally met for one meeting over a year ago and have not met since. Yet a phone call and promise from Mr Thurmond and a naive new commission backs down. If you had been watching Dekalb County government over the last four years you would know that in these cases Mr. Thurmond's promises are not worth the letters they are put together with
