Hoisting for non-ground floor access, unless specifically indicated above is not included.

Permits, if required, are not included and shall be provided by others at others expense.

<u>Flooring</u> -- Concrete slab must be level to 1/8" in a 10' radius and dry to 4.5# per 1,000 Sq.Ft. as tested by Calcium Chloride dry crystal testing methods. All slab prep work, including leveling, and associated cost is by others. Moisture test results must be provided to SSE prior to scheduling of crew to jobsite by others and at others expense. Thresholds, reducers, base and removal/reinstallation of anything on the floor (i.e. bleachers or floor inserts) which may be required are excluded unless specifically included above.

For Wood flooring contracts only; GC shall provide subcontractor with electrical service for floor sanders – 208 v./3phase/100 amps.
