DEMA is ensuring the county prepares, mitigates, plans responses and recovers from natural, man-made or terroristic threats as required by Georgia Emergency Management Agency. The purchase of two stationary generators are for emergency sheltering needs and capability.

Mason Mill Park and Exchange Park are designated county emergency shelter locations. They do not have capability to act as an emergency shelter if there is no power. It is hurricane/storm season and it is imperative to have power capacity in place. Generators are required in the event of power outages from storms, accidents, or any disaster. Currently, these locations do not have emergency power backup.

The requested vendor has experience installing the same style generators in various DeKalb County locations. Also, they provide maintenance services on all other stationary generators for DeKalb County. This ensures functionality and compatibility across equipment, parts, and sustainability during normal and emergency operations.

If this request is not approved, designated County shelters and residents in the area will not have emergency power capabilities in the case of a natural disaster, catastrophic event, or other power outage.



With regards to maintenance, testing, repairs and fueling of the units, per Kevin Buford, Facilities Management handles all the generators in the county. Each year a contract is renewed with P&ES to provide the PMs, testing and fueling. Fleet Services has shared that diesel fuel costs are averaging \$3 per gallon right now. The addition of two generators to the hundreds in the county will have minimal effect on the maintenance costs that will be absorbed by Facilities Management and it provides continuity across county equipment.

Every article sold by us is guaranteed free from defect in material and workmanship, and when shown to be defective will be replaced free of charge. F.O.B. works where manufactured, but all propositions are made with the distinct understanding that we are not to be held for any damages consequent to break-downs due to such defects.

Neither party shall assign or transfer this contract without the prior written consent of the other party.

4. TAXES

The prices do not include any present or future Federal, State or Municipal sales, use, gross receipts, property, or other similar type tax with respect to any material, erection equipment or services covered hereby. If the Company is required by applicable law or regulation to pay or collect any such type tax or taxes on account of this transaction or the material or equipment or services covered hereby, then such amount of tax shall be paid by the Purchaser in addition to the prices herein provided for.

5. INSURANCE

With respect to the performance of repair work at Purchaser's facility, the Company's personnel shall be properly covered with insurance in the areas of Worker's Compensation, Public Liability and Automobile Insurance where the use of a vehicle is required. To the extent any loss and/or damage is recoverable by insurance proceeds under Purchaser's insurance policies, Purchaser waives its and its insurers' rights to recover for such loss and/or damage against the company.

6. WARRANTY

The Company warrants that parts manufactured by the Company only and furnished under this contract, will be free of defects in material and workmanship for a period of 90 days from the date of installation, excluding transportation and installation costs (or 90 days from date of delivery if not installed by Company), and at its option, shall either repair or replace such parts, provided the Purchaser promptly notifies the Company of defects therein, within said period. The Company makes no performance warranty and the effects of corrosion, erosion and normal wear and tear are specifically excluded from the Company's warranty. The Company makes no other warranty or representation of any kind whatsoever, expressed or implied, except that of title, and all implied warranties, including any warranty of merchantability and fitness for a particular purpose, are hereby disclaimed.

7. LIMITATION OF LIABILITY
