Mission

INSPIRE Family Treatment Court's goal is to provide intensive holistic substance abuse treatment, break the cycle of addiction, allow children to live safely in their home, reduce recidivism, empower parents to successfully address other issues affecting a child's well-being, and build a foundation for a sober and healthy family environment.

*Parent participant must be 18 years of age or older, a resident of DeKalb County and meet program and clinical criteria in order to be accepted into the program.



The Program Consists of Four Phases

Phase I:
Igniting Change/Orientation Phase
(Minimum 120 Days)

Phase II: New Beginnings (Minimum 120 days)

Phase III: Revitalize Relationships (Minimum 120 days)

Phase IV: Proactively Seeking Success (Minimum 180 days)

*Depending upon the phase they are in, participants appear before the judge weekly, bi-weekly, or monthly



INSPIRE Family Treatment Court is an 18-24 month comprehensive program that utilizes a team approach to work with adults and children in DeKalb Family and Children Services (DFCS) custody who struggle with drug addiction. Participants will engage in longterm intensive treatment that includes:

Moral Reconation Therapy

- Treatment Recovery
- Empowerment Model Cognitive Behavioral
- Interventions for Substance Abuse
- Individual Therapy
- Group Therapy
- Frequent court appearances
- Random drug screenings
- Community-based support
 Other interventions may be
 required as deemed appropriate
 by treatment.

INSPIRE Family Treatment Court's staff and treatment providers adhere to policies and procedures designed to protect the participant's privacy.
