Dear Georgia Airport Sponsors,

The Coronavirus Response and Relief Supplemental Appropriation Act (CRRSAA) was signed into law by the President on December 27, 2020 and includes nearly \$2 billion in funds to be awarded as economic relief to eligible U.S. airports and eligible concessions at those airports to prevent, prepare for, and respond to the coronavirus disease 2019 (COVID-19) pandemic. The total amount of relief funds for Georgia is \$100,803,402, of which Commercial Service Airports will receive \$99,292,754 and Non-Primary Airports (General Aviation) will receive \$1,510,648. Included within the non-primary amount, four (4) general aviation airports with federal contract towers will receive financial assistance for cleaning these facilities and other airport operating funds spent to maintain this service.

Under the FAA's State Block Grant Program, the Georgia Department of Transportation (GDOT) will administer CRRSAA funding for Georgia's general aviation airports classified as Basic, Local, Regional, or National under the National Plan of Integrated Airport Systems (NPIAS). These airports will receive funding totaling \$1,510,648, of which \$136,648 will be dedicated to non-primary airports with federal contract towers. Unclassified Airports will not receive CRRSAA funds as specified in the Act. **Attachment 1-CRRSAA Funding Distribution** was developed by the FAA based on a formula described in the Act. These amounts are set by CRRSAA and will be provided at a 100% federal share, with no local match required. For more information on CRRSAA, please visit https://www.faa.gov/airports/crrsaa/.

GDOT highly encourages airport sponsors to apply for funds that can be spent immediately to help minimize any adverse impact from the current public health emergency. CRRSAA funding must follow the FAA's Revenue Use Policy and can be used for payments such as employee payroll, airport utilities, service contracts, and supplies incurred beginning on January 20, 2020. Sponsors may not apply for the same expenses that were documented in the previous CARES Act reimbursement program.

Under CRRSAA, airport sponsors of non-primary airports that participate in the FAA Contract Tower Program will receive additional funding to cover any lawful costs associated with supporting the contract tower operations, such as payroll, utilities, service contracts, and items generally having a limited useful life, including personal protective equipment, and cleaning supplies. Attachment 2-OMB SF-424, Application for Federal Assistance, must be completed and signed by each airport sponsor requesting funding under the CRRSAA. Several sections of the Application have been completed for ease and convenience, including the project description. Please note the requested federal amount should equal the amount listed in the CRRSAA Funding Distribution for your airport.

To supplement the Application, please complete **Attachment 3-Airport Operating Expenses-Budget Worksheet** as part of this package. Eligible items are outlined on the Worksheet. You may include expenses incurred since January 20, 2020 and estimated future expenses until the total equals the amount for your airport per Attachment 1. Not all items may be applicable to your airport and can be left at \$0.00. The Total Estimated Cost on the Worksheet should match the Application. The Worksheet

and signed Application must be returned to Colette Williams at cedmisten@dot.ga.gov no later than April 19, 2021.

For CRRSAA funding contracts, Airport Sponsors will continue the current practice of submitting pay applications and documentation to their Aviation Project Manager. Examples of documentation include payroll reports, janitorial or maintenance contract invoices, utility statements or invoices, proof of payment, and receipts for supplies. GDOT will process payments within 30 days of receipt of acceptable and supporting documentation. Sponsors must retain complete records to support requests for payments. All funds distributed under the CRRSAA are subject to FAA and GDOT audit to preclude improper payments.

If a Sponsor is not interested in applying for CRRSAA funds, a letter declining the funds must be sent to Colette Williams at cedmisten@dot.ga.gov no later than **April 19, 2021**.
