Do to the time required to receive our NTP (June 16, 2021) on the 2020 LMIG since the bid turn in October 2020, there has been a considerable change in the Liquid Prices. Therefore, we would like to request the following price changes: Here are two options for you to evaluate.

Liquid Index October 2020 \$422 Liquid Index June 2021 \$487 Difference of \$65.00 Patching A/C 5.33% at \$65 = \$3.47/t 9.5mm A/C 6.60 at \$65 = \$4.29/t

Option 1:

Pay per month

This is the current amount of asphalt placed.

June - Sept. Patching - 26,188.93 tns at \$3.47/tn = \$90,875.59

June – Sept. 9.5mm SPTP II – 5494.78 tns at 4.29/tn = 23,572.61

Option 2:

Lump Sum amount
Patching 84,560 tns at \$3.47 = \$293,423.20
9.5mm SP TP II 41,291 tns at \$4.29 = \$177,138.39
Total: \$470,561.59
