### C. COMMENTS FROM THE PUBLIC

The Public Comments portion of this meeting is reserved exclusively for comments from the public, and not for immediate reply. Each speaker must complete a speaker card and present it to the clerk before the beginning of the public comment portion of the meeting. The clerk will accept cards on a first-come, first-served basis. Speakers who are residents of DeKalb County shall be allowed to speak before residents of other counties are allowed to speak. Once the public comment portion of the meeting begins, speaker cards will no longer be accepted. Speakers will be allowed to speak for three minutes each and public comment shall not exceed 30 minutes in length.

When the buzzer sounds to indicate that time has run out, the speaker will be expected to immediately cease speaking and to yield the podium. Those who submitted speaker cards but did not speak because of the time allotment will be allowed to speak first at the next regularly scheduled Commission meeting without regard to residence. Speakers should always talk directly into the microphone and begin by stating their name, full address and the name of any organization they represent. Abusive, profane or derogatory language, holding up signs, clapping and yelling will not be permitted. A show of hands or quietly standing will be permitted to show support for or opposition to a speaker's position.

Citizens may speak for or against an item that is considered by law to be a zoning ordinance and each side will have ten minutes to presents its case. Citizens may also speak for or against an item that is placed on the public hearing agenda but is not a zoning ordinance. In that case, each side will have five minutes to present its case. In the event there is more than one speaker per side, speakers must divide their time in order to complete their full presentation within the ten-minute time allotment, or the five-minute time allotment. When the buzzer sounds to indicate that time has run out, the speaker will be expected to immediately cease speaking and to leave the podium area. Prior to speaking, please complete a speaker card and present it when approaching the podium. If you have any documents for the Commissioners, please provide 10 copies when approaching the podium. Seven copies are for the Commissioners and the remaining copies are for the planning director, the county attorney and the clerk. Applicants or citizens speaking in favor of an item shall speak first and applicants in zoning ordinance cases shall have the right to reserve time for rebuttal. Opponents of a zoning ordinance item shall have no right of rebuttal. Once the citizens have finished speaking, staff shall make a recommendation for action to the commission. At this point, citizens are no longer allowed to speak unless called to the podium by an individual commissioner to answer questions or provide information. When speaking, always talk directly into the microphone and begin by stating your name, address and the name of any organization you represent. Abusive, profane or derogatory language will not be permitted. Holding up signs, clapping and yelling to show support for or opposition to a speaker will not be permitted, but a show of hands or quietly standing will be permitted to show support for or opposition to a speaker's position.

### 3. Commissioner Steve Bradshaw read the following comments:

Today, I want to spotlight the progress being made on the Rockbridge Road Water Main Replacement Project. The Rockbridge Road project is on schedule with 50% of the pipeline work being completed. As the pipe is being installed, and the contractor is required to backfill the ditch at the end of the day and to place a concrete cap over the last 10-inches of the trench. To allow time for the concrete to cure, the plates are placed over the trench until the concrete cures which is usually about 3 days. Once the concrete has cured, the plates are moved along with the water main installation work. After the water main work has being inspected, tested, chlorinated and all curbing/sidewalk work has been completed, paving and final restoration work can commence.

The project is divided into 4 segments. Please keep in mind that delays may occur due to the rain. There will still be landscaping and permanent striping work to be done after repaying is complete; the whole project should be completed in the summer 2019.

I realize that driving on Rockbridge Road during this work has been challenging for commuters and to all of the commuters who have had to bear with the traffic delays, thank you for your patience and understanding. Honestly, it was challenging to drive on different sections of Rockbridge Road before the water main project. Improving infrastructure is usually daunting and frankly unpleasant for commuters. In the end, when it's all said and done the improvements are necessary. I am pleased with the progress that is being made on the project. I want to thank the men and women of DeKalb County Departments who are committed to a successful project; on time and on budget and mitigating inconvenience to constituents to the best of their abilities.
