Latonia Willis, 11 Tree View Dr., Lithonia, GA 30038 Good morning Commissioners and Thurmond's Administration, last week, the citizens of Dekalb County heard from another whistleblower who slipped Channel 2's Richard Belcher a copy of a disturbing audit report with findings of bid rigging, millions in overbilling and possible complicity by watershed personnel. The independent forensic accountant in the news story described the audit report as "one of the most egregious" audits he has seen. Nevertheless, the County's attorney, Terry Phillips, tells Richard Belcher these are old audits, and old issues that have been completed or in the process of being completed. Question, how old are the audits and what are the years? Why am I not surprised? Keep in mind the first whistleblower was a female named Theresa Slayton. In early 2018, the former senior purchasing official shined light on the problems in the County's purchasing and watershed departments; then fired. Slayton's lawsuit claimed illegal practices of collusion, bid rigging, violations of the Open Records Act, contractors overbilling of invoices, and more. Then, the administration attempted to assassinate her character to the public. Relatedly, these are identical accusations made in the latest audit report shared by another whistleblower. Oh, let us not forget the Hartman Firm audit report was hidden until Channel 2 received a draft copy. Then, the CEO has the audacity to call out Stacey Kalberman and John Greene relating to implementing the recommended changes to the County's purchasing policies. The CEO and his administration seem to challenge individuals who are rightfully trying to perform his/her duties and responsibilities as well as upholding the law. But the administration continues to keep and protect the employees/officials who are willing to lie, and cover-up in an attempt to deceive the public and taxpayers. The coverups continue. Hopefully, the Office of the AG, the U.S. Attorney's office and the DOJ are watching or have been notified to investigate these allegations outlined in the leak audit report. If these findings are true, no one should be above the law, including appointed, hired and elected county officials. Channel 2, keep airing the woes of Dekalb County until the government steps in and open an intensive investigation. To Commissioner Bradshaw, Commissioner Larry Johnson and Commissioner Mereda Johnson, I can always count on you to straddle the fence, to look the other way and remain silent when it comes to addressing the ongoing problems within the county. The three of you manage it well. I hope this public comment does not find its way in the junk or spam mailbox.
- 2. Dr. Ed Williams, P.O. Box 361626 Decatur, GA 30036 Good Morning Commissioners. DeKalb County is the 4th largest county in Georgia. Providing water and sewer service is a basic government service. We need a bill of rights with teeth that prevent citizens from having to pay unreasonable amounts for water. I would encourage the commission to reconsider its intention to take action on lifting the water billing problem cut-off moratorium. We are in the midst of a pandemic and citizens need to be able to wash and clean. Access to clean and affordable water is a necessity and an essential service. DeKalb does not need to be so quick to turn off the water. Public Officials have an oblimgation to be open and transparent and not violate the public trust. I recommend that the county keep the water cut-off moratorium in place and that the county focus on fixing the water billing problem and giving citizens some real relief. Do the right thing. Thank you
- 3. Stephen Binney, (no address) Commissioners, It is a sad time in Dekalb County. This county is built on Lies and the Lying Liars who tell them. A devastatingly critical audit that questions millions of dollars in spending by DeKalb Watershed is released by a whistleblower to the media. This private internal audit points to suspected bid rigging, collusion, and over billing. Seven of the eight transactions that they looked at had material errors. Nearly 90%, is this inefficiency or corruption? WSB asked for this audit nearly 2 years ago and was told the county couldn't find it and was unable to retrieve it. Lie! If this wasn't a Lie, why are these same jobs currently posted for hiring. Perhaps it was to get rid of the suspected whistleblower. Dekalb County, you are not nearly as clever as you think you are. You are a pathetic and morally bankrupt organization. A legacy land swap for no money which Blackhall Studios sells two months later for \$120 million dollars is getting conned. When asked about any 1.6 million dollar pledge he made to the community during the land swap negotiations, Mr. Millsap said honoring those commitments will be up to "the guys who bought it." "They bought this with no conditions," Millsap said. Less than a week later the LA investment group that acquired Blackhall are now asking Dekalb County to pay for road construction and other infrastructure improvements to this property.
