Kate McGregor Mosley, 139 Candler Oaks Lane Decatur GA 30030 - Dear Dekalb County Commissioners, Thank you for your service on our behalf during this critical time that calls for compassionate and strategic leadership. The pandemic has added layers of complications to your work and requires even more vision to ensure all in DeKalb thrive. But right now, too many are barely surviving. Our neighbors without houses need our community to come together like never before. We need warming centers and safe shelter for those who are living on the streets of DeKalb County right now. We need safe places where they can gather. We need DeKalb neighbors to show up for this vulnerable population. I implore you to act now to open these centers and to continue working with private-sector providers like A Home For Everyone-DeKalb and my clergy colleagues across the county as they serve these marginalized neighbors. Together, we can help protect them from the harsh elements and set them up for success in returning to permanent housing. Thank you for your consideration of this request. In hope,

2. Barbara McLean, 1444 Cornell Rd Atlanta GA 30306 - Thank you for providing an opportunity to share my concerns and for the work that you are tirelessly doing to help all of us. As a nurse associated with emergency and critical care I am witness to any given night , when temperatures drop below freezing Georgia's emergency rooms are flooded with unhoused patients exhibiting severely Low heart rates (bradycardia), life threatening hypoperfusion (vasoconstriction) severe neurological impairments (disorientation to coma), along with several other serious conditions that require work up and intervention. Initiated by an EMS call (if they are lucky) , followed by admission to a overwhelmed and expensive emergency room, created by an inhumane and preventable condition: failure to provide warm and safe places to sleep. The very signs and symptoms that are generated during moderate to severe hypothermia put our unhoused neighbors at more risk for assault, rape and other aggressive acts as they become confused , disoriented and sluggish from the cold. . The AJC reports that "... The official number from Fulton's 2019 reports...Nine people experiencing homelessness in Fulton died from hypothermia in 2019 per county records, almost one in four" of the reported deaths. Inaccurate counts of the number of our community who are compromised, humiliated and even die during nights that are freezing hides the fact that this it s a severe crisis. We ask that you continue and expand the good work of opening warm safe havens to assist our fellow Georgians. That your good work doesn't stop with five or ten shelters, but continues until all in need have a protected environment.

3. Paul McLennan, 851 Alberson Ct. Decatur, GA 30033 - Dear Commissioners, Thank you for your announcement last night about opening warming centers. We hope the county will continue to provide what is necessary for our unhoused residents, especially during cold weather. Everyone has the human right to an adequate standard of living which includes food, clothing, housing, medical care, and necessary social services. Truly affordable housing and the wraparound services required to sustain someone in a home must become a priority for all levels of government.

4. Dr. Sara Patenaude, 2417 Glenwood Ave SE Atlanta, GA 30317 - Dear Commissioners, We appreciate DeKalb County finally taking action to open three warming centers across the county for unhoused residents on freezing nights. As you no doubt realize, these centers are literal life savers. But we can and should do better. Our neighboring counties provide warming centers with a safe place to sleep, a warm meal, and available showers. They also take the opportunity to connect these people experiencing homelessness with the supportive services that can help them get off the street. In comparison, DeKalb County offers a folding chair in a fire station. What message does that send to the unhoused people of DeKalb County? Are they less worthy

of compassion and dignity by virtue of crossing over the DeKalb County line? As we enter into the holidays, please show your spirit of care. DeKalb County can and should do right by ALL of its residents. Any one of us is only 2 or 3 bad days away from experiencing homelessness ourselves. Providing a folding chair so folks don't freeze to death is the bare minimum. Let's set the bar higher in our county.

5. Stephen Binney (No Address) - Happy Holidays Commissioners, Santa Claus is coming to town later this week and I know what I want for Christmas. I want my County Commissioners to grow a spine. Either that or make a New Years resolution to govern like you have one. On Thursday evening, while changing the county redistricting meeting to 5pm to allow for more public participation, you decided not to allow the public to speak about the matter by only accepting public comments to be read into the minutes. Why is the commission afraid to allow the public to speak directly to them during public meetings? Mr Terry, your explanation while true was poorly stated. Under our current form of government in Dekalb County, commissioners are indeed mostly powerless, but to publicly state that all commissioners do is pass on requests for sanitation and water and sewage leaks so we do not need more commissioners because they would only get in the way is poorly stated. If that is the case, why do we have commissioners at all? Why are taxpayers paying out over \$250,000 a year to commissioners? Your examples of Gwinnett and Cobb as examples of counties with 5 commissioners does not sit well. Cobb and Gwinnett are democracies, Dekalb is more like a dictatorship. As proof of this, on Wednesday, during the OPS committee meeting, three recommendations to the Dekalb Legislative delegation failed to get an approval. A resolution to Eliminate Impediments To, Establishment, By Ordinance, Of A Transparent And Efficient County Procurement System, because as commissioners you are powerless to do so and Mr Thurmond is reluctant to do so. A resolution to Amend the DeKalb County Organizational Act Section 13 A to Allow the Board of Commissioners to make Appointments after a 90 Day Period, because the CEO is refusing to make some appointments. A resolution Relating To The Creation Of A Charter Review Commission To Study And Make Recommendations On The Governance Structure of DeKalb County because the CEO refuses to do so. Currently these three resolutions are now on hold because of promises made by the CEO's office. Do you cowardly lions believe his promises? Mr Thurmond has promised to make his appointments to the Charter Review Commission each of the last two years. What makes you believe him this time?

Commissioners, you can be part of the solution or part of the problem. If you are not part of the solution you do not belong here. Am I reading Item #3533 correctly? Dekalb County is going to be accepting up to a monthly average of 375,000 gallons a day of Rockdale's County's sewage into Dekalb County's sewage system at Pole Creek. 7. Dr. Ed Williams (No Address) - Good Morning Commissioners, My Name is Ed Williams, I have lived in unincorporated south DeKalb for over twenty years. I am the chair of the group Concerned Citizens for Effective Government. I have five major points to make this morning. 1. DeKalb County's method of funding the DeKalb Pension obligations is not equitable to all the residents in both unincorporated and municipalities of DeKalb County regarding legacy liability. 2. The BOC should require MARTA to restore all the Bus routes and schedules in DeKalb County. 3. The residents who live in unincorporated DeKalb interests are being neglected compared to the interests of the cities and the county as a whole. Unincorporated DeKalb must have proportional representation. 4. The CEO should appoint a new chair to the county charter review

commission. 5. DeKalb County should continue to invest in more coronavirus testing sites and quicker test results for the residents of DeKalb County. I have made several efforts to expose the inequities using the “see something and say something” approach and warn the commission. Today, I ask the board not to remain silent. Will you be the voice who says enough, and stand up and represent all the people? There is a disparity between municipalities and unincorporated residents in how the DeKalb Pension plan is being funded with the property tax funds. One of the problems with the DeKalb pension is that much of the liability was created before 2008 when more than 80 percent of residents lived in unincorporated DeKalb. The population has shifted to municipalities but the burden has not. The unfunded obligations of the pension should be paid from the county general fund. Other jurisdictions pay their pension liability from their General Fund. The commission should demand equity for MARTA services, Pension, and SPLOST funding. If you do nothing the people will seek redress from the courts. Thank You

8. Linda LeBron, 225 E Ponce de Leon Ave, Decatur, GA 30030 - I am Linda LeBron. I live in TowneSquare condo #512 at 225 E Ponce de Leon Ave, Decatur, GA 30030. Please open more warming centers. This county is blessed with too many resources to allow anyone to die in the cold. God bless all the volunteers in agencies working in this. Support them please!

9. Diana Berman, 128 Champlain Street Decatur, GA 30030 - Dear Commissioners- I want to thank the county for opening 3 warming centers beginning Wednesday night when the temperatures will dip below 35 degrees. Dekalb is a huge county. I would like to see more warming centers opened in different parts of the county located near public transportation. I'd like these centers to at least match the standards set by counties such as Gwinnett. For example, I think these centers should provide a warm meal, a safe place to sleep and showers. Transportation to these centers is also important. The county should provide this so our unhoused neighbors can reach the centers if they can't get there by public transportation. These centers are necessary. They provide life-saving food and shelter that our unhoused neighbors deserve. Thank you.

10. Ellen Gallow, 137 Inman Dr. Decatur, GA 30030 - Dear Mr. Thurmond and Commissioners, I am deeply saddened to see my neighbors and fellow DeKalb County citizens sleeping outdoors, especially on cold winter nights. Their very lives are at risk, and we, as a county, must respond. To as great an extent as possible, the county should provide motel accommodations with services to help move people into permanent housing. However, when this is not available, the county should provide easily accessible warming centers throughout the county. These can be at fire stations, police stations, recreation centers, other public buildings, and churches/houses of worship. Above all, the warming centers must be places where people feel welcomed and not shamed. As a county, we can, and must, take care of our neighbors who are at risk. Thank you.

11. Rev. Paul M. Turner, 601 West Ponce DeLeon Decatur, Georgia 30033 - Good Morning Commissioners, My name is Rev. Paul M. Turner, the Senior Pastor of Gentle Spirit Christian Church located at 601 West Ponce DeLeon Decatur, Georgia 30033. I want to thank DeKalb County for opening warming centers. However, 3 is only a start and is not close to the number needed for a county our size. I would call upon you to follow the standards set by our surrounding counties: more centers, providing a warm meal, showers, safe place to sleep, and transportation. I am sure you are aware, that Hypothermia begins with long term skin exposure of 50 degrees. Waiting till the temperatures have fallen to 35 degrees is waiting for people to die. Opening shelters at 40 degrees makes far more sense and will save lives. May each of you regardless if

you are a person of the Christian faith or not remember the teaching of Jesus: "For I was hungry and you gave me something to eat, I was thirsty and you gave me something to drink, I was a stranger and you invited me in, I needed clothes and you clothed me, I was sick and you looked after me, I was in prison and you came to visit me.' Each of you Commissioners have the ability to make sure no one in DeKalb County freezes to death. My hope is that you will act today rather than when someone has died.

12. Nancy Barrow, 928 E. Lake Dr. Decatur 30030 - When and where will warming centers be open in Dekalb County? So many people on the streets need a place to go for cold days and nights. These are our people and we must care for them. They are OUR PEOPLE. Thank you.

13. Mai Cavalli, (No Address) - My name is Mai Cavalli. I volunteer at the Assistance Ministry at First Baptist Church of Decatur at 308 Clairmont Ave, in downtown Decatur. Weekly, we serve homeless people providing them various services, referrals, Marta cards, food gift cards, gas cards, and as our budget permits help with paying phone bills, utility bills, and some short term hotel stay for newly the employed or seniors and disabled living on SSI benefits. We have a fair amount of homeless individuals who have told us that because of the lack of shelters or the fear of going to unsafe shelters, they sleep in the cemetery, on church properties including ours, in their cars if they own one, in parking decks. This is a shame, dangerous, and inhumane. We can and should provide safe shelters for all homeless, particularly during the winter months when sleeping outdoors can lead to death! Please help our homeless neighbors.

14. Tammy Washington, 2033 Castlegate Ter Decatur, GA 30032 - Thanks for opening the warming stations during this time. I have a few questions: How are you getting this information out to the community who it's meant to serve and the groups who serve them? Do you know how many who can be housed at each location? Having worked in warming shelters in DeKalb, I can attest to the dire need to provide a safe place during freezing nights. We all have a real responsibility to help protect our citizens from possible exposure and death. We, as a community have an obligation to these men, women, and children living on the streets. 16. Catherine Carter, 531 S Candler St Decatur, GA 30030 - My name is Catherine Carter. I am a lifelong resident of Decatur. My email is cwcarter531@gmail.com. Of course there have always been homeless folks in our town, but it seems to have become more apparent in recent years. Yes, public funds have been allocated to assist the poor and lessen homelessness. However, this 78 year old has received the calls indicating the difficulty of assessing these funds. Consequently these folks are unhoused. Whole families live in their cars or in tents. Many seek shelter in the Decatur Cemetery. In recent years several local churches have provided shelter on the coldest winter days. However, since the advent of COVID, this has become difficult, as most of the volunteers are elderly and more vulnerable to infection. The most that we at A Home for Everyone and DPC's Threshold Ministry are able to do is to hand out jackets, blankets, etc along with MARTA cards for transport to Atlanta shelters. This is offensive as numerous public buildings in DeKalb could be used to house the homeless. Please consider making shelter available in some DeKalb public buildings. Thank you,
