1. Ed Williams (No Address) -Dear Commissioners: State Court Judge Ronald Ramsey's political appointment to serve as chair of the Charter Review Commission has created an appearance of partiality and impropriety. Similarly, it would not be appropriate to appoint the solicitor general or district attorney. The charter commission is tasked to review the county charter which is the local statute that defines and specifies authorities, powers, and limitations of the political authority of county elected officials and engages the public. The CEO's appointment of Judge Ronald Ramsey to chair the Charter Commission Review Commission on or about February 11, 2022, to a commission that the CEO created through Executive Order creates a separation of powers issue and possible conflict of interest. The commission's task is to review the county charter in regards to the structure of county government, review of the county charter, and delivery of services. The appointment does not have anything to do with judicial matters or the interpretations thereof. It is related to revising the county's governing charter, such that it allows for better representation, responsiveness and provides better services. In reviewing the Code of Judicial Conduct and the opinions of the Judicial Qualification Commission, it is clear that the political appointment of Judge Ronald Ramsey to be chair of the county's Charter Review raises several issues of concern. The appointment of Judge Ronald Ramsey I believe runs afoul of several of the cannons of conduct. The judge's appointment to the county's Charter Review Commission raises questions regarding conflict of interest, independence, and judgment. The Code of Judicial Conduct rule 4.1 states that a judge shall not act or hold himself out as a leader in a political organization; It is not proper for a judge to participate in the political affairs of the county outside his judicial role while he serves on the State Court bench where cases related to the county officials, its business are likely to come before him, The Code of Judicial Conduct rule 1 states that judges are supposed to uphold the independence, integrity, and impartiality of the judiciary and shall avoid impropriety and the appearance of impropriety in all of their activities. According to rule 3 of the Code of Judicial Conduct, judges are supposed to regulate their extra-judicial activities to minimize the risk of conflict with their judicial duties. They are supposed to refrain from political activity inappropriate to their judicial office. See rule 4 of the Code of Judicial Conduct. The county charter is a political document that regulates the operations of the county government officials and the form of government. This practice and action are inconsistent with the Code of Judicial Conduct rule 2.4 which states "(C) Judges shall not convey or enable others to convey the impression that any person or organization is in a position to influence the judge." The judge's appointment as chair of the Charter Review Commission creates a situation where the Judge would be required to comment and make statements about a political document and process for which he should not comment and is obliged to refrain. See rule 2.10. The Code of Judicial Conduct 3.1 states that "(C) Judges may engage in law-related or quasi-judicial activities, provided that doing so will not interfere with the proper performance of judicial duties or cast doubt on their capacity to impartially decide any issue." Judges are allowed to appear before governmental bodies however there are restrictions. The Code of Judicial Conduct 3.2 states that "Judges may appear at public hearings before an executive or legislative body or official on matters concerning the law, the legal system, and the administration of justice, and they may otherwise consult with an executive or legislative body or official, but only on matters concerning the administration of justice" Lastly, it is clear that the Charter Review Commission scope goes beyond the improvement of the law, and addresses issues related to the form of government and policy other than improvement of the law. The Code of Judicial Conduct rule 3.4 states "Judges should not accept appointment to a governmental committee, commission, or other position that is concerned with issues of fact or policy on matters other than the improvement of the law, the legal system, or the administration of justice if acceptance of such appointment might reasonably cast doubt upon their impartiality or demean the judge's office." The CEO has stated that the purpose of the Charter Review Commission was to address issues related
to representation, responsiveness, the harmony of all parts, and delivery of services, among other things. It is significant to note that Judge Ronald Ramsey's current position is on the bench of the state court of the Stone Mountain judicial circuit. Which is responsible for adjudicating county ordinance violations and other state offenses which are also the subject of the county charter. Thank You
2. Paul McLennan, 851 Alberson Ct. Decatur, GA 30030-Good morning commissioners, Attached is our petition with over 1000 names that we are presenting to you on behalf of our coalition which includes Coalitions for Diverse Decatur/DeKalb, Beacon Hill Black Alliance for Human Rights, the Justice for All Coalition, and A Home for Everyone in DeKalb. We hope that you will listen to the concerns of residents in the county who think much more should be done to address the needs of the unhoused. Thank you for your time. We, the over 1000 undersigned DeKalb County residents, believe the issue of the unhoused in our community has reached a crisis point. Our unhoused are the most vulnerable on these cold winter nights, which have been here for over a month and have a long way yet to go. At these freezing temperatures, our neighbors have a high risk of dying of hypothermia if they remain on the street. Is that what county leaders want? So far, the county has chosen to only open three warming centers with minimal services to serve the entire county. Transportation is not provided and the fire stations now open do not serve those in the Central or Northern parts of this county. In addition, information about the warming stations is not available in time. When we finally do find out, it's too late to let people know. The county's communication personnel must know that weather can be accurately predicted in advance and act accordingly. Then we hear from county officials that the warming centers are hardly utilized. This is to be expected when the word gets out so late and no transportation is available! So far, we have heard reports of at least 20 families desperate for help, not counting the hundreds of single people, and there will be many more. The families tell us they are sleeping on the street and in their cars with their little children. What is the county waiting for? We demand the following: 1.) Open more warming centers throughout the county with adequate food, water, shelter, and wraparound services. 2.) Communicate openings at least 48 hours in advance of freezing nights. 3) Provide transportation for the unhoused to these centers. 4.) Address the more than 300 names of those people waiting for shelter.
3. Tammy Washington, 2033 Castlegate Ter Decatur, GA 30032- Good morning, I thank you for your service to DeKalb County. My email is in reference to homelessness. I ask that the county improve its communication when the warming centers are opening. No email was sent when the centers were opened last weekend. Also, what's the county's plan to assist the homelessness during the spring, summer and fall? Is there a plan to assist when the temperature increases \& prevent heat related illnesses \& issues? Finally, when will the final count from the homelessness count from last week be released? Thanks,
4. Stephen Binney (No Address)- Good Morning Commissioners, I wish to thank all the commissioners for their vote two weeks ago in support of super districts for Dekalb County, I believe it was necessary given the circumstances. However, I was concerned by Mr Thurmond's statement to the Dekalb Legislative Delegation. When asked by a delegation member which of the two redistricting maps he favored, he said he had no position and in fact had not even seen any of the proposed redistricting maps. I find that very disturbing since you are only the CEO of the Dekalb County. It doesn't matter now because you have made the final appointment to the Charter Review and they will start meeting again next month. I hope that all Dekalb County residents will take part in these meetings. Dekalb's charter is over 40 years old and needs to be brought up to date. Ranging from small procedure and procurement changes to considering establishing a Code Enforcement

Department which we are currently without. The most important changes will most likely concern the number and type of commission districts we will have in the future along with deciding if we still want to maintain our CEO style of government. Citizen input at these meetings will be very important. Please make your voices heard. Ms Davis-Johnson I apologize for offending you two weeks ago. I assure you it was not my intention. I wrote that you have lived with courage all your life and I did not mean your husband's courage. It takes way more courage for a woman than a man to have survived during the past and to continue to survive in today's world. Black women have it the hardest of all. Fighting the twin forces of racism and misogyny on a day to day basis is a never ending challenge and takes incredible courage. I do not want to be known as a male chauvinist pig like some others in Dekalb County government. I applaud both CEO Thurmond and the Commission for raising police salaries and benefits under the new budget today, However, I do wish to point out that even with the salary increases the pay of Dekalb County Police Officers will still be below those in the City of Atlanta as well as other local jurisdictions. I will take issue with your taking credit for adding 100 police officers under this years budget. When you were elected in 2016 the number of police officers needed to fully staff our county was listed at 1,240 . During your first year in office, in 2017, the active number of police officers was 835 with a projected number of 947 . In 2020 the active number of police officers was listed at 848 . Currently the number of police officers in Dekalb County is listed as 860 . During the 6 years of your time as CEO the county has added a total of 25 police officers, that is an average of 4 officers a year. Even with an additional 100 officers the County will only get back to the 2017 projected level. I don't call that increasing public safety. I call that maintaining the status quo. Meanwhile, we will still be over 250 officers short of being fully staffed while training some of the best officers in the metro area and letting them go to greener pastures, Thank you for your time and consideration,
5. Kenneth Taylor, 4828 Eagles Creek Circle, Lithonia- Mr. Presiding Officer, Mr. CEO, and Commissioners: My comments are related to the county budget that is presently under consideration. I recently reviewed the draft budget document that was recently submitted to the Board of Commissioners from the CEO's office. First, I am pleased to see that the CEO recognizes the importance of adequately funding our police department and other first responders. The proposed salary increases combined with retention bonuses and other initiatives should go a long way in getting the police department fully staffed and competitively positioned to recruit new officers. I hope that your focus on police compensation and staffing, however, does not lessen the equally needed focus on ongoing police training to make officers more effective on the street while doing what we all realize is a difficult and dangerous job. That training includes de-escalation of volatile incidents when possible, humanely managing interactions with individuals with possible or obvious mental health challenges, and implicit bias training. Also, I certainly hope Chief Ramos and her command staff embrace a community policing strategy and realize the long term and positive benefits that can accrue when officers establish relationships with the communities, residents and business owners that they serve. Additionally, I noticed you are also proposing higher funding for the district attorney's office. Due in part to restrictions imposed during the pandemic, I am aware there is a significant backlog in cases involving accused violent offenders, many of whom are repeat offenders. This situation is present at multiple DA offices across metro Atlanta and the country. I hope the added funding will enable the DA to bring indictments in a timely manner to avoid the possibility of these violent offenders being released and thus posing a threat to our communities. Also, I saw there is a modest increase in funding proposed for the Code Compliance and Enforcement Department. Effective code compliance and enforcement is critical to economic development, public safety and quality of life. Although I'm sure the community appreciates the additional dollars being allocated, I am more concerned
about correcting long standing and institutional failures in management, leadership and accountability related to service delivery. Dollars alone can't correct those problems; however, proper and sustained oversight and monitoring by the CEO and COO should effectively address them in the long term. In fact, I'm curious to learn what the county's response will be to the most recent draft internal audit report exposing these problems. There are a myriad of other budget related items that I believe deserve a sense of urgency in consideration that I won't address here out of respect for the time constraints in the public comment period. I will, however, say this in conclusion. As you plow through this annual budget season, please realize that the process is about more than just sifting through spreadsheets and making amendments about $\$ 1.2$ billion in proposed spending. Your decisions about how and where that money is spent will have consequences for the lives of thousands of people in DeKalb County every day. Because of that, we as your constituents, rate payers, and taxpayers deserve nothing less than your best efforts. Thanks to all of you for your service to DeKalb County.
6. Brain Aaron (No Address)- To CEO Michael Thurmond, and Board of Commissioners, as you all know today is the day to vote on the budget. However, I'm pleading with you all to please reconsider a final vote until something equatable is in place for other Essential employees. (Watershed, Sanitation, Fleet). Our CEO has made some tremendous steps within the County. However, this 14.1 million dollar addition for Public Safety isn't equatable to rest of the county employees. We all are facing staffing shortages due to people leaving for better pay, but the faithful few still show up and rise to the occasion. I humbly beg you all to please revisit this proposal before the final vote today. Take some time to come out to speak to the EMPLOYEES or have an Employee, CEO, and Commissioners committee. Again we ask in the most humbled manner to reconsider this final vote.
7. Benjamin Kinnard (No Address)- DeKalb Board of Commissioners, My name is Benjamin Kinnard and I live at 551 Clairmont Circle, Decatur, GA 30033. My comment today deals with the stretch of North Decatur Road between Clairmont Circle and Superior Avenue, as well as the intersection between North Decatur Road and Superior Avenue. I, alongside many others who live in the area, walk down this road several times a week to get to and from my bus stop for work, and while I am glad to have the option to take public transportation, I am deeply concerned about the safety of this stretch of road. The issues are as follows: 1 . The sidewalks adjoining the north side of North Decatur Road are old, narrow, and present a tripping hazard to those walking on them. At its narrowest point, there is only about 3 feet of space between the railing on the sidewalk and the street. I worry about the possibility of tripping on this sidewalk and potentially falling onto the road. 2. Traffic on North Decatur Road is incredibly fast and dangerous. The posted speed limit is 35 mph , but as traffic is going downhill on both sides as well as the road being a busy arterial road for commuters driving to and from the Emory/CDC area, cars often travel well above the posted speed limit, which poses a deadly hazard for pedestrians. There have already been at least two fatalities that I know of on this stretch of road in the past 10 years or so. I have already spoken to the Decatur City Commission about this subject. I understand that parts of North Decatur Road fall into the jurisdiction of the City of Decatur and that there are plans to eventually build a light rail line along this road, but I hope that you will overcome these obstacles and work with the City of Decatur to improve pedestrian safety. Thank you for your time and listening to my comment today.
8. John Leon (No Address)- Dear members of the DeKalb Board of Commission, My name is John Leon and I live just down the street in Decatur and I'm writing today to voice my support of the proposal put forward by Commissioner Ted Terry to create an Affordable Housing Committee. As we look ahead to our future, one
thing is certain. We won't get very far if we do not plan for the housing needs of the people in our communities - the people that make DeKalb County what it is. In the long-run, no one thrives if we price out our children who have the talent and skills to strengthen our businesses. No one thrives if small businesses are forced to close their doors because their rents are too high, and they can't attract or retain a workforce. No one thrives if families struggle to put a roof over their heads and parents can't provide care for their children. No one thrives when we are divided based on race and class. This issue matters for all of us - it matters for ALL segments of DeKalb If we fail to act swiftly to prioritize housing for people most in need, we all lose the ability to protect the legacy of this diverse region for our children and for the next generation, and creating a committee with the sole purpose and focus of developing thoughtful solutions to housing is a critical first step to do that. Likewise, CEO Thurmond creating a Chief Housing Officer, as most other major cities and counties have, is essential to showing we are taking this issue with the seriousness it deserves. I've watched the BOC meetings and various committee meetings, and there is simply not enough time for any of these bodies to provide the thought and attention that the current housing crisis demands. Housing, or a development, coming up in a BOC committee meeting is not in any way comparable to a committee seated with housing policy experts diving into topics like, ADUs, housing incentives, inclusionary zoning and land value taxes, and to imply that they do as Commissioner Larry Johnson did just a few weeks ago shows a profound lack of understanding about the seriousness of the housing crisis we face, and the complexity of the solutions we need to create to solve it. This is a common sense proposal that rightly prioritizes housing - and it shouldn't be voted down based on outdated ideas or egos. We need housing action, and we need it now. Take this small step, which is a recommendation from a report that was commissioned by this body, and create an affordable housing committee.
9. Scott Lange, 1246 Gracewood Ave SE- Hi, I live at 1246 Gracewood Ave SE in DeKalb County and I'm writing to support legislation to create an Affordable Housing committee. This committee is overdue and I very much hope you move forward with it. Thanks!
10. Steven Misner, 304 Heaton Park Dr. Decatur, GA 30030- Subject: Amendment to Chapter 13.5 (Historic Preservation Ordinance) of the Code of DeKalb County In 1993 the DeKalb County Board of Commissioners adopted the Historic Preservation Ordinance and created the Druid Hills Historic District to preserve the unique, historic character of the Druid Hills neighborhood. A major part of the unique character of the district was and is the Olmsted-drawn platting of the neighborhood, which created large, deep lots preserving the park-like character of the area. Due to the increasing cost of buildable land and the absence of available, buildable lots in the area, the original Olmsted platting is under continuous threat by subdividing or combining historically platted lots in order to increase density. Most recently, the Clifton Ridge subdivision litigation to maintain the original platting cost the county and Druid Hills Civic Association dearly. This loss was largely due to ambiguity in the DeKalb land development code as to whether the Historic Preservation Commission has the obligation and right to regulate the subdivision or combination of the lots within the historic district. The proposed legislation before you would make it clear that all subdivisions and aggregations of these historic plats must go through the Historic Preservation Commission in order to be permitted. It provides real protection and will effectively preserve the Olmsted platted lots which are an essential feature of the original, historic design.
