BOC approved Change Order No. 1 to increase the scope of work to allow for the substitution of two (2) Danfoss VFD pumps with the purchase of two (2) Allen Bradley VFD pumps and funding by an amount not to exceed \$99,482.27. On November 10, 2020, the BOC approved Change Order No. 2 to increase the contract term through December 31, 2021. On August 3, 2021, Change Order No. 3 was approved to increase the contract performance time through December 31, 2021. This request will allow the contractor the needed additional time to continue in the completion of the commissioning phase. Approval of this request will assist in the continued maintenance and improvement efforts at the Scott Candler Water Treatment Plant.
