Awarded by the BOC on August 25, 2015 for an amount not to exceed \$2,379,370.00. This contract consists of continued software licensing and maintenance support for iasWorld and its Computer Assisted Mass Appraisal (CAMA) module. Maintenance and support includes, but is not limited to, software upgrades, enhancements, bug fixes, defect support, and consulting services. This request will provide residents with web and mobile device access to their property and valuation data. The expansion will also allow the Property Appraisal Department to provide updated residential, condominium and townhome values for the 2018, 2019 and 2020 tax years.
