Consists of piggybacking off the competitively let Region 4 ESC/OMNIA Partners Cooperative Purchasing Agreement No. R170802 annual contract for the provision of trenchless technology rehabilitation and related services.

These requested services will assist DWM in completing over 360,000 linear feet of unallocated small diameter sewer line rehabilitation services under the Modified Consent Decree.
