PURPOSE:

To consider adopting the attached resolution creating Traffic Calming District 18-18-04 in Land Lots 50 & 61 of the 18th District, to consider authorizing the installation of traffic calming measures (speed tables) and appropriate signage on Park Lane (Between Densley Drive & N. Superior Avenue) & Superior Place and to consider assessing all properties in the affected area an annual maintenance cost of \$25.00

NEED/IMPACT:

Cut-thru traffic has been confirmed on Park Lane (Between Densley Drive & N. Superior Avenue) & Superior Place, which meets the criteria for traffic calming measures. Owners of 68.18% of the eligible properties in the identified affected area have signed the petition to have traffic calming measures installed. The public hearing has been advertised and appropriate signs have been posted notifying residents in the area.

FISCAL IMPACT:

The cost of initial installation of traffic calming measures is included in the Roads & Drainage Budget. All properties in the affected area will be assessed a yearly maintenance cost of \$25.00 during the life of the traffic calming measures beginning the first year after installation.
