To approve a resolution to appropriate Federal America Rescue Plan funds reserved for District 4 for the purposes of partnering with these organizations to assist with housing insecurity, utility relief, food distribution and essential needs as defined by American Rescue Plan criteria for use not to exceed \$200,000.

NEED/IMPACT:

DeKalb stakeholders servicing constituents have a need for financial support to provide essential resources and relief and support to DeKalb County residents affected by the COVID-19 pandemic. DeKalb Community Development Department will have oversight for the program management, and monitoring of the \$200,000 in funding allocations to community organizations.

FISCAL IMPACT:
