PURPOSE:

To appropriate District 7 reserves in the amount of \$7,500 to the DeKalb County Recreation, Parks & Cultural Affairs Dept. for the Briarlake Forest Park garden shed project.

NEED/IMPACT:

The \$7,500 appropriation will be used for a match for a Park Pride Grant for the Briarlake Forest Garden Shed project, which includes the installation of a concrete pad (Sudlow Concrete), shed assembly, and installation by Home Depot. A garden shed measuring 10x20 will provide storage for gardening and maintenance supplies. The garden shed will be maintained by members of the Friends of Briarlake Forest Park.
