PURPOSE:

Consists of providing design and engineering services during pre-construction, construction, and post-construction. Services will include, but are not limited to, preparing the Basis of Design Report (BDR); drawings; specifications; permit applications and supporting documentation to obtain all necessary permits; and coordination with regulatory agencies and utility companies. These design and engineering services, to support the upsizing of the trunk sewers, will contribute to the reduction or elimination of future sanitary sewer

overflows (SSO) in compliance with the Consent Decree mandates. Eight (8) proposals were received.
