Awarded by the BOC on June 9, 2015 for a total amount not to exceed \$12,000,000.00. On May 10, 2016, the BOC approved the 1st renewal option for a total amount not to exceed \$3,900,000.00. On April 25, 2017, the BOC approved the 2nd renewal option for a total amount not to exceed \$4,680,000.00. This request is for additional funding to sustain Consent Decree requirements and extend the contracts' term through December 31, 2018.
