#### **PURPOSE:**

Consists of piggybacking off the competitively let SWC for miscellaneous repairs and repainting of the Columbia Concrete Tank, Whites Mill Concrete Tank, Dunwoody Concrete Tank #1, and Dunwoody Steel Elevated Tank #2. The coating on tanks is well beyond its intended life and is in poor condition. The condition of the exterior surface at the top of the tanks are poor, with heavy delamination. The exterior walls of tanks have mildew and the coating showing signs of chalking, delaminating, and checking. Screens have holes and could create sanitary issues. The interior of the steel tank has corrosion around the seams, access hatch, overflow pipe, painters rings, sidewalls sheets, roof beams and vent. Completion of this work will update tanks appearance, improve safety, and continue to supply the County's residents with adequate and clean water.
