Awarded by the BOC on March 28, 2017 for an amount not to exceed \$163,800.00. On March 31, 2020, the BOC approved Change Order No. 1 for an amount not to exceed \$661,038.79. On November 10, 2020, the

BOC approved Change Order No. 2 to increase the contract term through December 31, 2023 and funds for an amount not to exceed \$853,508.40. On March 9, 2021, the BOC approved Change Order No. 3 for an amount not to exceed \$1,514,598.36. On March 22, 2022, the BOC approved Change Order No. 4 for an amount not to exceed \$2,786,413.38. On March 14, 2023 the BOC approved Change Order No. 5 to increase contract funds and extend the term through December 31, 2026. This request is to increase contract funds.
