## **PURPOSE:**

To consider pre-acceptance of WIOA Grants and a grant from Georgia Department of Labor not to exceed \$ 5,200,000.00 for employment and training activities for Adult, Dislocated Workers and Youth for PY 2018;

To consider authorizing the transfer of the funds when appropriate; and

To consider authorizing the Chief Executive Officer to execute the necessary document.

### **NEED/IMPACT:**

We received projection of Grant Funds Allocation from Technical College System of Georgia (TCSG), the new Governing body for WIOA grant funds. TCSG determines the allocations for WorkSource DeKalb. This pre-approval will permit expeditious handling in that time is critical for the Grant execution.

The Workforce Innovation and Opportunity Act (WIOA) provides separate funding for Adult, Dislocated Workers and Youth for employment and training activities. These funds will be used to provide these Workers with job search
