The awards are for Gresham Park, Truelove Park, Hamilton Park, NH Scott Park, Stoneview Park and Cedar Park.

NEED/IMPACT:

The Recreation, Parks and Cultural Affairs Department has received six grants from the State of Georgia Governor's Office of Planning and Budget.
