## **PURPOSE:**

Awarded by the BOC on April 28, 2020 to two (2) vendors for a total amount not to exceed \$10,000,000.00. On February 10, 2022, Change Order No. 1 was approved to transfer \$1,000,000.00 from Contract 1213057 to 1213056 due to heavy usage. On April 26, 2022, the BOC approved Change Order No. 2 to increase contract funds to both contracts by a total amount not to exceed \$5,000,000.00. On December 27, 2022, Change Order No. 3 was approved to transfer \$2,000,000.00 from Contract 1213057 to 1213056. On January 27, 2023,

Change Order No. 4 was approved to transfer \$500,000.00 from Contract 1213056 to 1213057 for payment of outstanding invoices. On March 14, 2023 the BOC approved Change Order No. 5 to increase contract funds to both contracts by a total amount not to exceed \$10,000,000.00. These contracts consist of the provision of part-time and full-time temporary personnel positions for DeKalb County on an as needed basis. This request seeks to increase the contract term through June 30, 2025, using existing funds.
