PURPOSE:

To consider adopting a resolution to set a date and time for a public hearing related to the potential abandonment of a 42,344 SQFT (0.97-acre) section of right-of-way known as Koppers Road and a 29,339 SQFT (0.67-acre) section of right-of-way of an adjacent unnamed road.

NEED/IMPACT:

The owner of property that abuts the referenced right-of-way sought to be abandoned, has requested a 42,344 SQFT (0.97-acre) section of right-of-way known as Koppers Road & an adjacent 29,339 SQFT (0.67-acre) section of unopened right-of-way to be abandoned.

State law requires that a public hearing be held on a potential abandonment of right of way.

The County Attorney's Office has reviewed the attached resolution and has approved it as-to-form.

FISCAL IMPACT:
