NEED/IMPACT:

The Film, Music & Digital Entertainment Commission is charged with marketing and leading strategic initiatives that attract film and entertainment projects to DeKalb County. The DeKalb Film, Music & Digital Entertainment Commission works closely with Decide DeKalb and DeKalb Count, providing leadership and strategic direction on issues related to the film, music recording and production, and entertainment industries. The DeKalb Film, Music & Digital Entertainment Commission budget proposal was presented to the Committee of the Whole, on Tuesday, April 4, 2017.
