PURPOSE:

On November 30, 2023, the incumbent contractor provided a notice of termination for parking management services for the Trinity Parking Deck and Camp Road Surface Lots, effective December 31, 2024. As the loss of the management company resulted in a material loss of essential government services, an emergency six-month

contract was executed with a local vendor. The vendor provided a quote for Parking Management Services for both locations and an agreement was reached for a 35% revenue share for each location. A competitively let procurement process for these services is in progress. This request seeks to ratify an Emergency Agreement, effective December 29, 2023. This request also seeks to continue services through September 30, 2024 to allow time for new contract execution.
