PURPOSE:

To consider the attached Resolution, Order and Declaration of Taking for acquisition of certain right of way and temporary easement in Parcel 19 (Owner: First United Methodist Church of Tucker, Inc.) needed for the Tucker Streetscape, Phase II Project (“the Project”); and
To consider authorizing the Chief Executive Officer to execute all necessary documents.

NEED/IMPACT:

The condemnation will enable the County to include the subject property in the Project to construct a sidewalk along Fourth Street from Railroad Avenue to Lavista Road. The required property interests are valued at \$58,700.00 and a certified letter has been sent to the property owner.

The County Attorney has reviewed the attached documents and approves as to form.

FISCAL IMPACT:

The fiscal impact to DeKalb County is \$58,700.00. The funding source is Georgia Department of Transportation (GDOT) funds.
