Awarded by the BOC, on March 27, 2018, for an amount not to exceed \$3,000,000.00. On June 25, 2019, the BOC approved the 1st renewal for an amount not to exceed \$2,120,380.00. On June 9, 2020, the BOC approved the 2nd renewal for an amount not to exceed \$798,600.00. On June 8, 2021, the BOC approved the 3rd renewal for an amount not to exceed \$1,341,835.00. increase the contract term through December 31, 2023. This contract consists of providing technical, professional, and administrative staff to execute land and easement acquisition services and other related activities associated with land and easement acquisitions.
