#### **PURPOSE:**

State law allows counties to object to annexations under certain circumstances. DeKalb County received notice from the City of Atlanta on or about October 26, 2023 of its intent to act on a proposed annexation petition via the one hundred percent (100%) method submitted by SMART Hotels Georgia, LLC. The Petition seeks to annex approximately 1.72 acres into the City of Atlanta, including properties located on N. Decatur Road and Emory Drive. The County Attorney and relevant County staff are investigating grounds for a potential objection to the proposed annexation.

The County anticipates providing the elected officials with a substitute item containing specific grounds for the objection for adoption and approval at the Board of Commissioners meeting on December 5, 2023.
