**PURPOSE:**

A scrivener’s error has been found in the “Proposed Amendment to the DeKalb County Code of Ethics” attached to the Resolution (item 2019-4831) adopted by the Board of Commissioners on January 14, 2020. Subsection (C)(2)(A)(ii) was inadvertently duplicated over subsection (C)(2)(B)(i). This amendment corrects this error and restores the correct wording for subsection (C)(2)(B)(i).
