Awarded by the BOC on November 14, 2017 for an amount not to exceed \$7,241,636.00. At the time of the original bid, the contractor was not able to complete a thorough internal inspection of the tanks due to the hazardous field conditions that are still present on site. This request is to increase the performance time by 117 days and to add a work allowance for completion of current and any future unforeseen work associated with the roof replacement of the three (3) potable water ground storage tanks.
