**PURPOSE:**

Awarded by the BOC on July 24, 2018 for an amount not to exceed \$3,000,000.00. On August 27, 2019, the BOC approved Change Order No. 1 to add \$1,000,000 in additional SPLOST funding. On December 17, 2019, the BOC approved Change Order No. 2 to add funding in the amount of \$30,000.00 from District 2 Park Bond funds for a concrete slab for Frazier Rowe Park Pavilion to the SD&C contract (1139824). On March 31, 2020, the BOC approved Change Order No. 3 authorizing the addition of line items such as traffic control and grading required to complete the work. This request is to authorize the addition of line items such as rip rap, filter blankets, and drain basins (including concrete) that are necessary to complete projects but were not included in the original solicitation scope of work or pricing for the project.
