PURPOSE:

Awarded by the BOC, on June 22, 2021, as a cooperative agreement in an amount not to exceed \$5,249,250.00. On December 12, 2023, the BOC approved Change Order No. 1 to increase the contract term through June 30, 2025. This contract consists of piggybacking off the competitively let City of Eastpoint annual contract for the

performance of water valve condition assessments and evaluations. These services include locating, accessing, and clean-out of the valve structures; the collection of over 30 valve attributes and capture of a sub-foot GPS locate; and the documentation of necessary work orders that will allow for valve operability. These services also include locating and collection of attributes for fire hydrants; capture of a sub-foot GPS locate; and the documentations of necessary work orders.

Xylem Inc., the parent company of Pure Technologies US, Inc. and Xylem Dewatering Solutions, Inc., approved the transfer of all assets associated with the Wachs Water Services business from Pure Technologies U.S., Inc. on June 20, 2023. Wachs Water Services is operating under Xylem Dewatering Solutions Inc. dba Wachs Water Services.

This request seeks to transfer the existing contract's remaining funds and contract terms. A consent to assignment will be developed and executed in a form acceptable to the County Attorney. There will be no additional change in contract terms, conditions, or prices.
