**PURPOSE:**

Awarded by the BOC on September 10, 2019, for an amount not to exceed \$1,584,000.00. This contract consists of the use of proprietary software that allows the County the capability to create publicly accessible GIS Apps/Dashboards/Maps, deploy software and is fully integrated in other departmental workflows and business systems. This software has been utilized by the County since March 2011. It facilitates emergency

services, police, fire, water/sewer services and citizens alike to maneuver the County and locate emergency calls with no deviation in course. The manufacturer is the only supplier that can provide annual maintenance, training and professional services. This request is to extend the contract for an additional one-year period in order to negotiate and budget for a new multi-year Enterprise Agreement.

**RECOMMENDATION:**
