### **PURPOSE:**

Allocate \$100,000 from the District 1 Category \$1M - Commissioner District Transportation Projects Funds to Atlas Consulting for a Multijurisdictional Regional Traffic Study to analyze existing traffic conditions

### **NEED/IMPACT:**

The study will analyze existing traffic conditions and expected future conditions with and without improvements in Gwinnett and DeKalb Counties. The primary goals of the study recommendations will be to accommodate where appropriate truck traffic, relieve congestion, and build walkable/connected communities divided by infrastructure. The study will include observations and recommendations for the nearby intersections and surrounding area.

The DeKalb County study area will include the following streets and areas:

- Pleasantdale Rd at Oakcliff Rd
