#### **PURPOSE:**

State law allows counties to object to annexations under certain circumstances. DeKalb County received notice from the City of Atlanta dated January 23, 2024 of its intent to act on a proposed annexation petition via the sixty percent (60%) method submitted by Steven Jones. The Petition seeks to annex approximately 23 acres into the City of Atlanta, including properties located on Flat Shoals Road and the Collection at East Lake townhome community. The County Attorney and relevant County staff are investigating grounds for an objection to the proposed annexation.

An authorizing Resolution is attached to this item. The County anticipates providing the elected officials with a substitute item containing specific grounds for the objection for adoption and approval at the Board of Commissioners meeting on February 27, 2022.
