Awarded by the BOC, on March 8, 2022, for an amount not to exceed \$2,885,000.00 for the purchase and installation of pool & aquatic buildings, shower houses and multi-purpose buildings for the Pool Renovation Project at NH Scott Recreation Center. On July 26, 2022, the BOC approved Change Order No. 1 in an amount not to exceed \$1,590,000.00 for the purchase and installation of a Storage/Scorekeeper Booth at Midway Park and three (3) restroom buildings at Exchange Park. This contract consists of the purchase, installation, and all things necessary for the purchase and installation of public restrooms and other structures.
