PURPOSE:

Awarded by the BOC on June 8, 2021 to three vendors for a total amount not to exceed \$800,000.00. On June 14, 2022, the BOC exercised the 1st renewal to two vendors in a total amount not to exceed \$800,000.00. This contract consists of providing disaster recovery cleaning services of water and sewage and supplementary services for repair to systems affected by spills from heating, ventilation, air conditioning, and plumbing.

On July 22, 2022, Bell sold all property, inventory, and contract rights to Wilpro. Wilpro will conduct business as Wilpro Enterprises, Inc. dba Servpro. This request seeks a Consent to Assignment to transfer the existing contract's remaining funds and contract term from Bell to Wilpro.

There will be no additional change in contract terms or conditions.
