PURPOSE:

- 1.To consider pre-acceptance of WIOA Grants, not to exceed \$ 6,500,000.00, for employment and training activities for Rapid Response, Adults, Dislocated Workers, Youth, SNAP, and other like grants for PY 2017;
- 2. To consider authorizing the transfer of the funds when appropriate; and
- 3. To consider authorizing the Chief Executive Officer to execute the necessary document.

NEED/IMPACT:

We understand from our Granting Agency, Georgia Department of Economic Development Workforce Division, that there may be some additional funds for each grant other than what we have been allocated for PY17. Georgia Department of Economic Development Workforce Division determines the allocations for WorkSource DeKalb. This pre-approval will permit expeditious handling in that time is critical for the Grant execution.

No funds have been received or expended and no workforce activities are being conducted for the above mentioned grants.
