### PURPOSE:

This ordinance changes the hours of operation for all businesses which provide alcoholic beverages for on-site consumption. Currently, alcoholic beverages may be served in a variety of establishments until 3:55 a.m. This ordinance will change that time to 2:00 a.m. for Sunday through Wednesday, and 2:30 a.m. for Thursday

through Saturday..
