PURPOSE:

Awarded by the BOC on March 10, 2015 for an amount not to exceed \$818,973.67. On October 27, 2015, the BOC approved Change Order No. 1 for an amount not to exceed \$1,750,744.78. On March 22, 2016, the BOC approved the 1st renewal option for an amount not to exceed \$845,779.41. On February 28, 2017, the BOC approved the 2nd renewal option for an amount not to exceed \$1,027,475.41. On March 13, 2018, the BOC approved the 3rd renewal option for an amount not to exceed \$851,128.47. This request is for additional funding to provide necessary upgrades to help protect against current cyber threats, as the County's current net security system is obsolete.
