PURPOSE:

Awarded by the BOC on November 10, 2015 for an amount not to exceed \$6,050,000.00. On November 7, 2016, the BOC approved the 1st renewal option for an amount not to exceed \$4,900,000.00. On November 14, 2017, the BOC approved the 2nd renewal option for an amount not to exceed \$4,825,000.00. This Change Order is to request SPLOST funding for Contract No. 990970 in the amount of \$375,000.00 and an additional \$200,000.00 from the Police Fund for the purchase of specialized equipment for police vehicles. This request is to extend all awarded contracts for three months through March 31, 2019 and add funding in the amount of \$915,619.00 to allow time for the completion of processing a new solicitation to establish new contracts.
